TRAINING:

- Officer Stebbins attended Taser 7 instructor recertification on July 21st at Wright State University.
- BC Prosecutor's Office provided updated training on the topics of search and seizure and evidence.

TOPICS OF INTEREST:

- Fairfield Township Police Department participated in the 2021 Butler County Fair. Thank you to Spec. Darrell Prewitt for organizing the event, and all of the CPAA members who volunteered their time to sit at the booth.
- Sexual assault of a minor in the 1400-block of Tuley Road. Detectives were called out and investigated throughout the night, served a search warrant, and arrested a female suspect and booked her into the BC Jail.
- UC Hospital called and said a 20-year-old female arrived at the ER advising she was sexually assaulted in Fairfield Township. This case remains under investigation.
- Male arrested at Walmart for shoplifting and for having methamphetamine on his person. The officer
 recovered the drugs and booked the subject into the BC Jail for Theft and Possession of Drugs (F3). A female
 acquaintance was also arrested for her involvement in the theft.
- 2600-block of Hamilton-Cleves Road for two males overdosing in their car in the middle of the road. Both subjects received Narcan and treated by Ross Township and Hamilton fire departments before being transported to Fort Hamilton Hospital. A female acquaintance was arrested for warrants out of Warren County.
- A bullet went through the upstairs window of a house in the 6900-block of Morris Road. No injuries reported and it is possible someone carelessly fired a firearm. There is no evidence to suggest that the home or area was targeted by anyone for any reason.
- Officers and detectives responded to 2700-block of Rochester Avenue for a deceased 22-year-old female. Butler County Coroner's Investigators took the decedent, and it does not appear there are any signs of foul play at the scene.
- Officers recovered a stolen van at the bike path park on Canal Road and located a male in the back of the van. The subject had multiple felony warrants and was booked into jail. Officers also recovered hypodermic needles from the vehicle.

- Injury crash on eastbound SR129/SR4 Bypass exit ramp. One vehicle sideswiped another vehicle and lost control, causing the vehicle to strike a light pole, rollover, and eject the driver from the vehicle. The driver suffered non-life-threatening injuries and was cited for the crash.
- Speedway on Tylersville Road for a fight between a group of people in front of the store. A complainant alleged
 that a vehicle full of young adults pulled up behind them and attacked them with baseball bats and fled the
 scene. The other subjects were located and stated the complainants started the altercation. There were minor
 injuries; however, it was unclear if any weapons were used and those involved refused to cooperate.
- 3200-block of Indian Meadows for a fight. One neighbor had a verbal dispute with another neighbor over smoke bombs being set off in the back yard. Each of the two neighbors stated it turned physical and that the other person struck them in the face.
- 6100-block of Hollyberry Lane for a domestic violence incident involving a knife. The male, violating a
 protection order, broke through the front door and entered the house where the altercation took place. The
 male assaulted the female and fled the scene. This case is pending and warrants issued.
- Liberty Fairfield for a tree that had fallen onto a vehicle. A large tree fell onto Liberty Fairfield Road blocking both lanes and striking one vehicle. The tree caused disabling damage to the vehicle; however, no one in the vehicle was injured. Officers conducted traffic control on Liberty Fairfield.
- While conducting problem-orientated policing in a neighborhood, officers stopped a vehicle on Tuley Road for a speeding violation. The driver was found to have an outstanding warrant for trafficking in dangerous drugs (Felony 4). Officers arrested and booked the subject in to the Butler County Jail.
- Officers responded to Dick's Sporting Goods for a shoplifting complaint. The suspect took off and officers caught the suspect after a brief foot pursuit. They located an uncapped and loaded syringe and a powder substance (fentanyl). Officers recited him on several outstanding warrants and the drugs were taken as evidence. Felonious drug possession charges are pending the crime lab report.
- 2114 Fairfax Avenue for an assault and damaging report. An unidentified white male reportedly threw a brick through the window of a vehicle and struck the driver. This case remains under investigation.
- 4000-block of Summerdale Lane for a burglary where a suspect entered an open garage during the daytime and stole a golf bag and its contents. The \$1,300 worth of stolen property has since been recovered and a suspect identified.
- 2900-block of Hamilton-Mason Road for an injury crash involving a car into a utility pole and an unresponsive driver. Officers detected signs of impairment and the driver received medical attention. He was subsequently charged with OVI.
- 4100-block of Hamilton-Middletown Road for a theft of a 16-foot trailer from a business.
