- Congratulations to Officer Zach Steele and Officer Trent Smith who were sworn in as the newest police officers to join the department. Welcome to the team!
- Sgt. Miller held three simunition training sessions at Butler Tech to train officers in active shooter response and tactics. The training included scenarios with high school role players from the criminal justice program.
- On September 2, 2022, FTPD obtained an arrest warrant for 18-year-old Jordan Spain for his involvement in the 2018 murder of 16-year-old Sydney Garcia-

Tovar. On September 6<sup>th</sup>, Miami Township PD (Clermont Co.) located Spain and arrested him on the outstanding warrants. FTPD picked up Spain who is currently incarcerated pending his case. In April 2021, MarkeyInd Townsend was also arrested for his role in Garvia-Tovar's death.

- The Citizen Police Academy is scheduled to begin in February 2023 and we are currently seeking participant interest from residents, as well as those who work or own a business in the township. - The police department assisted outside agencies during a search warrant in the township that yielded multiple firearms. As a result of the in-depth investigation, those agencies also recovered a large quantity of drugs and other contraband in other jurisdictions.
- 3050 Anchor Drive evening shift officers responded to Frisch's for a felonious assault. A female allegedly took her partner's vehicle without permission. The owner of the vehicle attempted to stop her by clinging to the hood of the vehicle as it drove away. The owner of the vehicle was then thrown from the hood of the car and sustained minor injuries. The suspect was later located in Fairfield and arrested for felonious assault and domestic violence.
- 3213 Princeton Road Colerain Township PD requested assistance in locating a shooting suspect. Officers located the subject at Wendy's and took him into custody without incident; however, he did have a loaded handgun in his waistband. The subject is under disability due to a prior adjudication for a violent felony and FTPD charged him with Having Weapons Under Disability (F3) and Carrying Concealed Weapons (F4) and booked him into the BC Jail.
