- Congratulations to Officers Michael Thompson and Cameron Wood who were sworn in as the newest officers to join the department. Welcome to the team!
- The Citizen Police Academy Alumni planted a tree and donated a plaque in the park in memory of Carol Oler. Carol was an active member in the community and her husband, Mike Oler, was present for the ribbon cutting. Mike worked for the FTPD for approximately 15 years and organized our CPA Program.
- Evening shift officers responded to the 6300-block of Morris Road for a subject reported to have shot himself and shot into traffic in Hamilton shortly before. The officers encountered the subject, the subject ran into a wooded area, and officers from multiple agencies set up a perimeter. The subject ended up on Tara Brooke Court and HPD officers shot him after he pointed a gun at them. It was later determined that the subject had just committed a homicide in Hamilton prior to entering the township.
- Officers responded to Tuley Road on two occasions for a dispute between a mother and her daughter. The juvenile cut herself with a knife and was transported for medical treatment.
- Speedway (Creekside Drive) for a driver who intentionally struck another vehicle during a road rage incident. The complainant stated the subject showed a knife and then swerved over and struck his vehicle. The suspect was located and charged with Aggravated Assault (F4) & Criminal Damaging (M2).
- Officers assisted multiple agencies from Montgomery, Warren, and Butler counties after armed suspects in a stolen car shot at police officers up in Dayton, fled from police, and ditched the car in Tyler's Creek Townhomes. All subjects located and arrested without further incident after an extensive search.
- Officers responded to Best Buy for a robbery. The suspect brandished a knife on the employees and stole electronics before fleeing the area. He was located and arrested shortly after and booked in the BC Jail.
- 3200-block of Cheyenne Court for an assault report. The subject was gone when the officers arrived and officers determined it was a domestic situation. They issued a warrant for Domestic Violence (F4 – w/priors).
- Walmart for a female who concealed merchandise and then assaulted a loss prevention employee while fleeing from the store. Officers learned the identity of the suspect and issued a warrant for robbery (F-2).
