- The department has been awarded up to \$9,935.25 to purchase body armor for our officers as part of the 2022-23 Ohio Law Enforcement Body Armor Program. This is the 4<sup>th</sup> year in a row FTPD was able to obtain this funding toward body armor reimbursements.
- The department received a reimbursement in the amount of \$2,989.63 for the 2021-22 Ohio Law Enforcement Body Armor Program.
- The department obtained a \$4,000 grant from Walmart. This grant goes toward the police department's annual Shop with a Cop program in supporting kids and families in the community who are in need.
- Officers responded to Camargo Trailer Park to assist a case worker for an emotionally disturbed person. While on scene, the subject exited the trailer with a butcher knife and claw hammer and charged the officers. One of the officers shot the subject for his safety and the safety of the community. The subject went back into the trailer, and the officers were able to secure him and begin first aid. The subject was then transported for medical treatment.
- Several calls involving car break-ins. One resident reported his wallet was stolen while another resident reported a handgun was stolen – both from unlocked vehicles. We continue to urge everyone to please remove valuables from their vehicles and lock their doors.
- A passer-by turned in a handgun that he found on the side of the road in the Five-Points area (not related to the above case).
- Officers responded to a domestic violence incident where the female caller was able to get to a phone and call for help. She had visible bruising to her face as a result of her husband punching her when they were driving around. The domestic occurred within the city limits of Huber Heights and the suspect was transported to Montgomery County and turned over to Huber Heights Police who charged him with Domestic Violence.
- Officers responded to the 1900-block of Parrish Avenue for a domestic violence where a male punched his girlfriend. The male suspect was arrested for domestic violence and for resisting arrest.
- 7500-block of Wildbranch for a car theft. Officers located the vehicle and the suspect jumped out and ran away on foot. This case remains under investigation.
- El Rancho Nuevo for a robbery report. An employee reports an unknown subject wearing all black ran straight behind the bar and assaulted him before fleeing with cash. This case remains under investigation.
