- Chief Chabali was appointed to the Ohio Peace Officer Training Commission (OPOTC) by Governor DeWine. The commission consists of ten members appointed by the governor and issues recommendations to the Attorney General about matters pertaining to law enforcement training. Chief Chabali is one of two chief of police positions on the commission as required by the Ohio Revised Code.
- The police department started the 2023 Ohio Collaborative recertification process and has a goal to finalize it within three months in preparation for the on-site visit by a state assessor.
- The 2023 Fairfield Township Spring Cleanup was a success township wide. The police department landscaping was tidied up along with adding some flowers and other plants around the building.
- All sworn members of the police department are starting to work on the required 24 hours of continuing professional training (CPT) hours as required by the state. Eight (8) hours consist of school threat and safety training, legal update, and arrest, search, and seizure. The remaining (16) hours will be at the direction of the Chief of Police and meet the requirements as set forth by the Ohio Peace Officer Training Commission (OPOTC).
- Chief Chabali and Captain Lanier attended the annual Ohio Association of Chiefs of Police conference. The guest speakers and workshop topics consisted of: "Emotional Survival for Law Enforcement Officers and their Families", "Recruiting, Hiring, Retaining and Developing Peace Officers in the 21<sup>st</sup> Century", "Employment Law Decisions Affecting LE Management", "Visions on the Future of LE Looking Through the Lens of Diversity, Equity, and Inclusion", "Criminal Asset Forfeiture Funds: Role and Responsibility of LE", "AMBER Alerts & Missing Person Investigations for Administrators", "Critical Incident Review", and more.
- Detectives arrested an adult male for several charges related to a child pornography investigation that started back in 2022. The case is pending in Butler County Common Pleas Court.
- The Investigations Section received new information and are investigating another child pornography case. They served multiple search warrants related to the case and the suspect was arrested on six felony charges and is set for a grand jury hearing.
