From Fire Chief Timothy J. Thomas Sr., OFE OFC

2019 has been a year of great progress for the department. One of the highlights of the year, certainly has to be the completion of the long-awaited replacement of Station 212 on Tylersville Road. This station has been a huge part of the history of Fairfield Township and the Fire Department.

Many former members had spent their entire fire department careers responding from the station. They lived through the multiple additions and remodeling over the years. The old station will always hold memories and the hearts of Fairfield Township Fire Department. As we began moving things from the old to the new it was interesting to hear the different conversations. The members who had spent their careers in the old building reminiscing and telling stories of the things that happened back in the "volunteer" days. The new folks excited to be moving to the bright shiny new building.

This year we were finally able to open the new facility on Gilmore Road. The dedication was held on May 11th. Over 100 people attended the ceremony. The Department was able to open a new state of the art fire station. The new building has been designed to allow for the department to continue to grow. The station has the ability to have up to ten members on duty, with individual bunkrooms for each member.

Apparatus now enjoys four, eighty foot, bays with housing for up to 8 pieces of equipment. The Fire Safety Trailer now has a new home inside, and the service vehicle no longer has to sit outside. We moved the reserve apparatus over to Station 212 which helped to alleviate the crowding at Station 211.

Members working at the new facility now have plenty of room to operate from. We have added storage rooms and purpose-built rooms to meet the demands of

today's fire service. We have hopefully designed enough extra space to allow for the changes that will be coming to the department in the future.

The new building is equipped with, a state of the art, digital sign. This allows the department to share important information and safety messages with the public. The Township also installed similar signs at the Police and Administration buildings. This system allows the signs to be adjusted electronically allowing for important information to be displayed very quickly.

The crew took great care to move William "Bill" Gray to the new building. The display in the front lobby of his gear gained the approval of the firefighters as well as by Bill's family during the dedication ceremonies. We are pleased that he will continue to watch over our operations and serve as a reminder of our risks and responsibilities. The display cases also contain mementos from other former members of the department.

We look forward to making new memories with in the walls of the new station. At the same time, we will treasure the memories and history from Tylersville Road.

Personnel changes during the year also were a major activity. Two of our members left our fulltime positions for other opportunities. We were able to replace them with the hiring of Greg Hoelle and Christopher Ferguson. We also were able to increase our authorized strength with the addition of a fulltime Fire Inspector position.

We continue to struggle with staffing issues. While the full-time staff that we have, has certainly made a huge improvement, there are still concerns. The pool of viable part time employees remains limited. We face a struggle with keeping our standards high. This can result in us not hiring some of the applicants. I am sure that keeping our standards will pay the most dividends. We will continue our efforts to recruit additional part time staff.

Logan DeBord who serves as a member of the reserves has been deployed since the beginning of 2019 and is expected to return to work in early 2020. We were able to hire Brennan Berter late this year, who will cover the shift opening until Logan returns. At that time one of the fulltime members will move to the day turn Fire Inspector position. I anticipate this in the first quarter of 2020.

The creation of the Inspectors position will help the department to improve the quality and consistency of our fire safety inspections. Having an individual specifically assigned to this task will help make sure we are keeping up with things like blue print reviews, new construction inspections, foster home inspections, adoption inspections, and the fire safety education

programs.

The Drug Bag Exchange program is continuing to work well. This has virtually eliminated costs associated with expiring medications, medications shortages, and continues to help with our operating costs. Westchester Hospital Pharmacy has been a great partner in this program. We look forward to continuing this program with them. The medical supplies are vital to the success of our operation. I just want to thank Howard Jackson, now a Firefighter/Paramedic, who continues to manage this inventory.



The department received our new radio equipment. The Township decided to purchase new radios at the end of 2018. The units were delivered to us in early 2019. We returned all of the portable radios owned by Butler County. We have continued to use the mobile units that are installed in our vehicles. We will begin transitioning to the portable adapters as we replace vehicles or as mobiles are not repaired or not serviceable.

The Fire Department along with the members of the Fire Corps participated in both the Annual Spring Cleanup as well as the "Rock the Block" event. Members assisted with these two cleanup activities helping to assist township residents with disposing of refuse. It was truly a township wide event.



The fire department continues to support the many community events throughout the year. We have been a part of the annual Easter Egg Hunt, Cleanup events, Bridgewater Falls events, as well as safety days at many of our businesses. I am looking forward to an increased level of participation with the staffing of the fire prevention position.

Members again were asked to work providing EMS coverage for the Butler County Fair. We provided coverage for the week-long fair. We were assisted with support during grandstand events by St Clair Fire Department. This provides our members exposure to the attendees and helps residents, while visitors learn about our department.

The round-about at Gilmore and Hamilton Mason Road was completed. This project impacted our response to the 5 points area during the construction. This should help to alleviate some of the traffic issues we experienced trying to negotiate the old intersection. We are looking forward to the widening project proposed for the remaining section of Gilmore in 2020.

The other major road project within the Township has been the Liberty Fairfield road widening. This project will continue and extend into 2020. When it is completed, it should improve our ability to travel during emergencies.

The construction of the Storypoint project, which began in 2016, continues to be a long and drawn out affair. In December of 2019 it was finally able to open the three-story independent living section of the project. Residents began moving in in December. The department worked closely with the Butler County Building Department and the Contractors, working through their request for a phased approval process. The project has undergone three changes in project management since the start of the construction in 2016. Once they complete the front of the building they will begin focusing on the rear part of the building. We welcome our new neighbors. We expect this facility to result in increased requests for service.

One of the potential tenants of Storypoint contacted us about the exterior lighting on the outside of our building. He was concerned the light would create a problem due to the intensity. We were able to work with Wargo Electric to change the type of fixture to a shielded unit. This prevents to light from traveling out and keeps it focused down and closer to our building. We were able to take the old fixtures and use them on the Administration building. These fixtures were LED and will help improve the lighting at the Administration Building and the Park. If also fits inline with the changes that have been made at Station 211. We are working to change all of our exterior lighting to LED units to help conserve energy. We have done the wall packs on the building. We are hoping to work on the parking lot lights in 2020.




We continue to update our computer equipment. As we have to accommodate the move to Windows 10, we have replaced additional desktop units this year. We are also working to replace the hard drives on our Mobile Data Terminals (MDT). After researching with Ami from Southwest Ohio Computer Association (SWOCA), it was determined switching the hard drives to new solid-state drives would allow us two additional years of service before we need to look at replacing these five units.

We are still waiting on action concerning the phone system. I am awaiting action from the administration concerning the possible replacement of our phone system. We were able to extend extensions to the new building to provide phone service there. Before we continue with any further modifications or changes, a decision on replacement must be made. The current system needs to be updated to improve the service. We are hoping this will move forward in 2020.

Several major capitol projects were completed this year. We were working to prepare for purchase of a new engine and a new squad. We had delayed the process for the purchase of these units due to restrictions on vehicles sizing requirements at Tylersville Road. Once the new station was opened those restrictions were no longer an issue. In October and November, we received authorization to move forward with the vehicle purchases. We have purchased a new Braun Am-



bulance from Penn Care Medical and a new E-One Engine from Vogelpohl Fire Equipment. Both of the units will be delivered in 2020.

As a part of our capitol project request, we were also authorized to purchase new fire hose. We were able to purchase over \$44,000 of replacement fire hose. As a part of this purchase we decided to eliminate "Hamilton" thread from our trucks and return to National Standard Thread (NST). As this thread was used by only Hamilton City it was decided that it would be more beneficial to use NST which would make us compatible with the other agencies in the area.

We also were able to purchase a new set of extrication tools as well as a new stabilization kit. The new tools are Genesis Battery Operated units. Allowing us to eliminate the hydraulic hoses and allow each tool to operate without restrictions created by hydraulic lines and their lengths.



Captain Ryan Berter and Firefighter Paramedic Jason Jeffers took on the majority of the engine and equipment purchase project. They should be commended for the extra effort put forth on this. I would also thank the other members of the department who helped with this process.

Port of our process was to equip the new truck so that we would then have a fully equipped reserve. This would eliminate the moving of most of the equipment when the reserve truck was placed in service.

The department has also experienced a significant increase in calls for service this year. During 2018 we actually saw a slight reduction in calls for service. This year we experienced an increase of 350 calls over last years numbers. This brings the department to a new record number of 3200 calls for the year.

As we move into 2020, we have been working on a new strategic planning document. This five-year planning document helps the department develop a direction and plan to meet the goals that have been put in the plan. This helps the identify issues and items that we must resolve in order to accomplish our goals. The plan identifies some of the financial obligations that exist with meeting the goals. It is designed to help with planning for the future and making our goals into reality. A draft of the plan was given to the Officers for review. We look forward to making some additional improvements in the plan. I am hoping to begin implementing the plan recommendations beginning in early 2020.

As you read through this annual report you will see the results of the hard work and efforts of all staff members. Each member of the department is a vital part of the success of the Department. The Officers have prepared a brief report of activities and projects from the year. Included are charts and statistics that help explain the activities during the year.

I am proud of all of the staff and I owe them thanks for all of the hard work they put into this Department every day. With their continued support and efforts, we will continue to be a successful team.

I would also like to thank the Administration, Police Department, and Service Department. They have always been more than willing to assist the Fire Department in completing our mission. Every member of the Fairfield Township staff continues to provide the highest level of service to the residents and visitors of our community.

In closing, as I look back at the past seven years, I am proud of the progress the Fire Department has made. We have overcome a number of issues. This has only been accomplished with significant effort by all members of the team.

And by team, I mean the current and past firefighters, current and past administration staff, and of course the current and past Trustees. It is only with their efforts that the progress has continued. I am looking forward to what we can continue to accomplish in the future. I welcome the coming year with excitement and look forward the new opportunities that await us.

























Every day it is the mission of the fire department to deliver superb all-hazards emergency response to our residents and those that visit Fairfield Township. We accomplish this by continuously evaluating our service and delivery and comparing it with industry best practices. Below are some highlighted items from 2019.

The Bureau of Workers Compensation (BWC) provides grants each year to assist organizations provide a safer workplace. We applied for a BWC grant to purchase new cancer prevention hoods for all our members. These hoods prevent the cancer-causing particulates from getting to our head and neck. Each member now has one of these hoods, one step closer to preventing cancer.

This year we updated our reporting software and internet access in our vehicles. The previous equipment was very old and outdated. This allows us to keep up with reporting requirements from the State of Ohio and prevents our members from getting behind on reports during busy times.

Since we switched reporting software, we also had to update the way we do payroll. Our previous reporting software allowed us to track our employees' hours worked very easily. Our new reporting software does not have that ability. The Township utilizes a payroll system that has an app where employees can login from a smart device or computer and

enter their hours worked directly into the payroll system. This reduces time spent on payroll and increases efficiency for payroll.

With the new fire station being built we had to update our response territories to better serve our community. All of that information has to be entered into the computer aided dispatch system, which then determines which apparatus respond to the different sections of the Township.

Throughout the year we stay very active learning and teaching with our surrounding fire departments. We participated in a joint Active Shooter scenario with Liberty Township and Ross Township. We taught Incident Command training to Oxford, Liberty Township and Trenton Fire Departments. It is very important to train

with our local fire departments to make sure we all work together seamlessly during emergency situations. We continue to find ways that we can all collaborate and work better together.

Fire Prevention

Throughout the year the fire department continues to keep fire code enforcement as a top priority. The enforcement of the Ohio Fire Code plays an essential role in fulfilling our department's mission to prevent the loss of life and property. In addition to ensuring that existing structures are maintained in accordance with the Ohio Fire Code, the Fire Department spends countless hours reviewing plans for new construction within the Township. These reviews are conducted to ensure that new buildings in Fairfield Township are as safe as possible for patrons and employees alike. This method of code enforcement ensures appropriate measures are taken to keep emergency responders as

safe as possible in the event of an actual emergency and helps ensure that emergency operations can be conducted safely and efficiently. The fire department is also continuing to educate building owners about the importance of Knox Boxes. The Knox Box Rapid Entry System is a small, all mounted safe that holds building keys for firefighters to use for entering an unoccupied business in cases of emergency. This 24/7 access allows us to enter and resecure a structure, eliminating the need for costly forcible entry. Knox Boxes are also available for residential applications. Similar to commercial applications, the residential Knox Box allows firefighters and paramedics the ability to gain access to a residence during emergencies where the homeowner is unable to open the door for our crews. Knox Boxes truly help expedite the emergency response without causing unnecessary and costly damage to property. These can be borrowed from the fire department on a temporary basis.

The on-duty crews continue to attend daily trainings to assure we provide an up to date professional service to the community and to obtain the hours needed to recertify our current certifications.


HYDRANTS

Engine 211

I oversee daily/yearly maintenance of E 211 and all its equipment.





SCBA

I oversee the maintenance and ordering of all SCBA equipment. I am a certified MSA technician able to work on repairs in house instead of sending them out to an outside service. We have had our new msa g1 air packs for a year now and they have been great. Little to no maintenance so far. All Firefighters are assigned their own personal mask. In 2020 I am planning on sending two more individuals to get MSA Tech. certified.

Quartermaster

I oversee all the ordering of station supplies for both firehouses. In April 2019 we moved all our cleaning supplies to Cintas. They now sup-

ply us with most of our stock. They are in once a week to both stations to always keep our stock current. Matt Metzner has been my go-to at station 212. With his help things have gone smoothly with the opening of the new Firehouse.


In 2019 we continued with our plan of rotating gear out of service every 10 years as required by NFPA 1851. We purchased 15 new sets of turnout gear which allows us to remove 15 sets of gear from service.

Members continue to conduct annual fire inspections, occupancy inspections and numerous public education programs throughout the year.

Fairfield Township continues to work with the Butler County EMA to provide support with county wide response. One of these areas that we participate is maintaining and oper-

ating Task 2 which is a 52' Semi Truck that carries a large supply of Hazardous Materials supplies. This truck requires our members to operate the vehicle as well as maintain the items stored inside including the annual testing of 20 Level A Hazardous Materials Suits. Task 2 makes numerous responses throughout the year which requires our members to respond and operate in conjunction with other agencies within Butler County.

We were able to make several purchases at the end of 2019 that we are very excited about. The first was the acquisition of battery powered rescue tools. These tools are at the leading edge in the field of auto extrication and we are proud to be able to put them into service in January of 2020.



The second purchase was for a replacement pumper. A committee was formed and after an exhaustive process we selected the EONE corporation out of Ocala Florida to build our next pumper. Working hand in hand with the sales staff and engineers at EONE we finalized and placed the order in early December. We expect this

build to take 15 months and we look forward to seeing this engine serve the citizens of Fairfield Township for many years to come.

We look forward to 2020 and the challenges that will no doubt come along with it. We look forward to continuing our effort to build the relationships throughout our community that allow us to provide the best possible services to the citizens and visitors of Fairfield Township.

Staffing

Staffing began to stabilize in 2019 as we have added additional members to the part time roster. With this additional staffing, the incidents of running minimum staffing at each station has been in decline. As we move forward, we are better equipped to manage our run volume and duties with this additional staff.

Communications

In 2019, the trustees approved for purchase replacement radios for all departments (police, fire and services) in the township. This purchase replaced aging equipment that was no longer supported by the manufacturer. The new equipment allows the department the flexibility to adapt to upcoming changes to the radio repeater system that would not have been supported by the previous model. This would have forced the replacement of the equipment at a potential higher cost as the equipment was purchased at a discount. Since this equipment is owned by the township, all components were added into the running inventory. Only a few mobile mounted radios remain in service, however they will be removed soon.

Disciplinary Actions

I am happy to report that no incidents occurred requiring actions. The speaks volumes to the quality and caliber of the staff we have here. These employees are well rounded and well suited to the profession we have chosen, as living conditions in the fire department are 24 hours at a time for crews in close quarters. This type of work is a stark contrast to normal office environments and the fact that our staff lives and works without incidents is a testament to their abilities.



Hydrant Maintenance

Hydrant maintenance went very well again this year. Hydrants were completed efficiently and effectively with no injuries or major events reported. Fairfield Township has in excess of 1600+ hydrants that are tested annually. Of those hydrants, only 10 were found to have maintenance issues this year. We continue to have a good working relationship with Butler County Water and Sewer who have been great in getting these hydrants back in working order in a timely fashion. We continue to improve the 'Hydrant Maintenance' program each year and I have some new



Please accept the following 2019 EMS Annual Report from the Fairfield Township Fire Department medical direction team. Over the past 12 months, 12 hours of direct medical director/assistant medical director-led continuing education were performed in station. This included topics such as:

Protocol Review

Airway management

Pediatrics

Seizure disorders

Pharmacology

This was complimented by an additional 24 hours of office time and impromptu education, during which time the medical direction team was able to perform ride-along activities on several occasions facilitating invaluable crew field observation and real time QA/QI activities..

Through the UC Division of EMS, we concluded our every other year 40-hour paramedic refresher course, begun in 2018. This course included additional medical director-led lectures as well as several simulation sessions using high-fidelity patient simulators.

Several large operational changes begun in 2018 were successfully continued throughout 2019, including the use of the ENCharge electronic patient care record and the FTFD/West Chester Hospital drug bag exchange.

Looking forward to 2020, educational hours and office time will remain unchanged. We will continue to cover fundamental EMS topics as well as focusing on areas for improvement identified through the CQI process. In the fall, we will again conduct the first half of a 40-hour paramedic refresher, leading to 2021's recertification deadline. Prompted by the realization of delayed recognition of at least one patient care concern, we hope to increase and reorganize our quality improvement program to increase medical direction team involvement.

As always, the medical direction team will remain available for any and all Fire Department EMS needs.



2019 was challenging as always. 2019 was also the first complete year with our full-time career firefighters. The transition has worked well with notable improvements in department communications and everyday operations. I look forward to the continued progression and hope to see continued progress into 2020. Among the excitement we moved into station 212, this station was a long-overdue replacement to the old station. Station 212 is serving the fire department and community well. While I have only worked at the station a few times, I am impressed with the improvements over the old, outdated station.



The FTFD engine committee organized by Captain Berter met with vendors and local departments throughout the second half of the year. The committee gathered design ideas for a replacement engine. Our prima-

ry focus was to build a new fire engine to replace an older, outdated rig while efficiency, safety, and ease of use remained the driving force throughout the design process. We steered clear of the trends of today and an all-in-one bell and whistles apparatus for a streamline to-the-point engine that fits the Fairfield township fire department. Our design saved thousands of dollars on a rig that will perform as intended on an emergency scene without wasteful trends found in many other agencies. The conclusion was an engine design from E-One; I am excited to see it arrive. I am proud to have served as a member of this committee.



2019 was a busy training year for my crew and I. I continued my coursework for my B.S. in Fire Service Administration, ending 2019 75% complete while obtaining a 4.0 GPA. I attended the Miami Valley Fire and EMS Conference in February 2019, which provided several lectures and handson training evolutions taught by some of the best fire firefighters in the industry. I completed Fire Officer 2 in January, Fire Officer 3 in September, and finished the series with Fire Officer 4 in November 2019. ACLS recertification December 2019. Finally, I attended 100% of the training topics for the Butler County Technical Rescue Team.

While I was busy training off duty, several of my shift members were also dedicating their off-duty time expanding their fire service knowledge. Crew members attended fire officer courses (1,2,3), fire inspector, HAZWOPER Tech, TECC, Advanced Airway, Courage to Lead, ACLS instructor, BLS instructor, Stop The Bleed, and LACK. Firefighter Tony Shroyer completed the rescue technician training series through BGSU. Rescue technicians are skilled in Water, rope, trench, confined Space, Auto/machinery, and building collapse rescue. My shift now has three members trained in this highly technical field. In 2019 FTFD members on the BCTR team assisted in several emergencies proving the value of their craft. A few examples of responses made by our members include:

*Fairfield Township: Possible person in the river; nothing found.

*Fairfield Township: missing child search at Bridgewater Falls resulted in the location and reunion of child and family.

*Ross township: A farmer trapped neck-deep in a silo of soybeans was rescued unharmed. Hours of vigorous work were involved in the successful outcome.

*Cincinnati: A parking garage under construction collapsed, killing one worker. Team members assisted in the recovery of the Construction worker.

*Most recently, the assessment and search of a Middletown apartment complex that exploded after a gas leak. These exceptional members are an invaluable asset to our FTFD roster.

Shift 1 experienced no shortage of work on duty. Between emergency calls shift 1A completed all assigned fire safety inspections, including several impromptu inspections for private and adoption homes. Several small repairs performed in



house to tools and equipment reducing the need for costly outside maintenance or downtime of equipment. Countless new employees worked with our shift learning how to be capable firefighters in Fairfield Township. Firefighter Scott Smith worked extremely hard developing and building a fitness area for the new fire station 212. I have worked in the new station a couple of times and can say the fitness facilities available for the staffing at 212 are fantastic. He has acquired top of the line weight lifting, cardio and circuit equipment for our use. I commend Scott for his effort on this project.


In closing, I look forward to the challenges and advances 2020 will offer.



Paramedic Howard Jackson

For fiscal year 2019, \$70,758.33 was appropriated for the purchase of non-capital EMS supplies. These include supplies that are single-patient use, supplies that have expiration dates, or reusable supplies that do not meet the definition of capital items, including:

IV catheters

Cardiac monitoring supplies

Vacuum splints

Backboards, straps, and cervical immobilization devices

All pharmaceuticals, including oxygen and IV solution

For fiscal year 2019, \$60,178.40 in purchases were made.





For the first time since I began my duties as EMS Inventory Manager and submitted these annual summaries, the availability of supplies has not been a concern this year. Because of our participation in the UC Health Drug Bag Exchange program, the availability of pharmaceuticals has not been a concern of ours, due to UC Health being responsible for obtaining and supplying those pharmaceuticals. Many of our surrounding departments are having difficulty obtaining certain medications because of nationwide shortages.

In 2018, and again in 2019, Bound Tree Medical purchased two of our previous vendors – Concordance Healthcare Solutions and Southeastern Emergency Equipment. Thankfully, the only changes that have been witnessed are some reduction in prices, as well as reducing the number of vendors necessary to find the lowest possible prices. At present, we primarily

purchase from three vendors: Bound Tree Medical, Henry Schein EMS, and Penn Care. Purchases are made from Stryker and Teleflex

for specialty or direct-from-manufacturer items. During January and February 2020, I will continue the past practice of submitting item lists to our vendors for pricing and selecting the vendors with the lowest price.

Probably the most visible change in EMS inventory has been the opening of the new Station 212. As the transition was made from the construction to the occupancy phase, we began the process of moving all our bulk storage to the new EMS Bulk Storage warehouse. With this change, the department regained the conference room at Station 211. Additionally, supply room inventories were changed; instead of providing an exact count each week, crews



now select from a list of options, with some of those options sending an alert that stock needs to be replenished. Needed supplies are gathered and then delivered to the requesting station.
