Sergeant Miller completed the Police Executive Leadership College (PELC) training. The course consisted of 20 instructors, 20 required readings, four research papers, five community interviews, three team projects, and three speeches including a final capstone presentation. This is a tremendous accomplishment for Sergeant Miller as he looks forward to applying the leadership concepts and skills he learned.

Summer Holiday Enforcement Program (SHEP Grant) runs April 1 – Sept. 30, 2024. Grant funds are used for traffic safety education/awareness and traffic enforcement/visibility (e.g., OVI, seat belt, distracted and reckless driving).

On March 21, 2024, Sgt. Brandon McCroskey spoke with a group of parents at Cincinnati Christian Schools on Morris Road about online safety and the dangers associated with social media and technology.

FTPD Officers assisted the Blue Ash Police Department with locating a suspect and vehicle involved in a road rage incident in their city. The suspect fired shots (from his vehicle) at the victim while they were driving on I-275. FTPD officers located the suspect and the car at the house here in Fairfield Township. The suspect was taken into custody and released to Blue Ash PD. He was later charged with attempted murder and other serious crimes by Blue Ash PD.

Officers conducted a well-being check on a home that is in the process of being remodeled and has a history of being used by homeless people. Officers assisted the property owner and located two homeless people inside the home. They both were arrested and taken to BC Jail, and one of them was also wanted for questioning in connection with a homicide case from the City of Hamilton.

Officers responded to Walmart for a suspicious male touching his groin and photographing women without their consent. Officers located and arrested the subject and booked him into the BC Jail. This case remains under investigation involving possible previous incidents.

Walmart for a male subject opening bottles of shampoo and pouring them down his pants. When the officers detained him, the subject physically resisted the officers before being taken into custody. He was charged with resisting arrest and criminal damaging.

SR4 in front of Butler Tech for an OVI crash. The intoxicated driver, who had two children in the rear seat of his car, was arrested for OVI and endangering children.

The Investigations Section issued warrants for a subject for B&E and theft after he broke into a resident's shed and stole items.

James Stroebel pled guilty in Butler County Common Pleas Court to one count of Attempted Robbery (F4) that occurred at Best Buy last year. He committed a similar offense in the Columbus area and is pending sentencing.

Jamie Hayre pled guilty in Common Pleas Court to (8) felony counts of Pandering Obscenity Involving a Minor (F4) and Illegal Use of a Minor in Nudity Oriented Material for a child pornography case investigated by our detectives. He is pending sentencing.

Suspects broke into the new Tidal Wave Car Wash on Princeton Road and stole approximately \$8K worth of tools. Before the reported theft, midnight shift officers documented information on a suspicious vehicle and occupants to detectives. A person of interest was identified and charges are pending in this case.

Officers responded to the area of Bypass 4 near SR 4 for a two-vehicle injury MVA. One of the vehicles was operated by a 17-year-old male, whose vehicle rolled over and he had to be extracted from the vehicle by the fire department. He was transported to a local hospital.

Officers responded to a residence on Greenlawn Road for reports of seven people trying to get into the resident's property. Officers determined that the caller was under the influence of alcohol and drugs. The caller had an outstanding warrant for his arrest and he was booked into the BC Jail.

A 2001 Ford Explorer was reported stolen from Jessie's Way. The stolen vehicle was returned to the owner a couple of days later.

A 2005 Hyundai Elantra was reported stolen from Allstatter Avenue. The vehicle was located and recovered in Huber Heights.

Midnight shift officers responded to an active domestic dispute and criminal damaging on Connor Court. The complainant advised the subject left the scene and officers located the vehicle traveling on Morris Road shortly thereafter. The complainant refused charges; however, officers arrested the driver once they determined he was under the influence of drugs and alcohol. The driver was booked into the BC Jail.

Midnight shift officers conducted a traffic stop on an unsafe motor vehicle in the 2700 block of Tylersville Road. Officers detected signs of impairment and arrested the driver for OVI. Officers also cited the vehicle owner for wrongful entrustment of a motor vehicle.

Officers conducted a traffic stop for speed on SR4 near Walden Ponds Drive. Officers detected signs of impairment in the driver, and the driver later refused to complete field sobriety testing. He was arrested for OVI.

Officers received information from social media posts regarding a couple of crimes. First, a felony theft of \$1,125 worth of merchandise from JCPenney – this case remains under investigation. The other crime pertains to a B&E on Pater Avenue. Officers were able to identify the suspect from previous interactions and issued a warrant for his arrest.

Officers responded to a report of a stolen vehicle on Wildbranch Road. Officers located the vehicle nearby and discovered it was occupied by a juvenile relative of the owner. The juvenile was charged with unauthorized use of a motor vehicle.

Dayshift officers have made several arrests this month responding to Flock "hits" and locating the suspect and/or vehicles. It continues to be a great asset during investigations.
