Homicide Suspect Sentenced – On December 15, 2022, Anthony F. Brown received a sentence of 26 years to life in prison for the May 2022 shooting that killed Adam Black inside Walmart. In addition to the prison sentence, Brown has an outstanding Aggravated Robbery case that occurred in Hamilton, for which he could receive more than a decade in prison. *Great job to all the officers, county prosecutors, and other local law enforcement who worked together to bring justice for the victims in this case!*

Task Force – Sergeant Roach (TFO), in his role with the U.S. Marshals Office Task Force, was a lead investigator and directly involved in the apprehension of three violent fugitives wanted for crimes that occurred in Butler County. These cases included a fugitive wanted for a 1997 murder in the City of Hamilton, a fugitive wanted for a 2022 vehicular homicide in the City of Middletown, and a fugitive wanted for a 2025 complicity to murder in the City of Sharonville. Sergeant Roach received words of appreciation from the Butler County Prosecutor's Office, the Hamilton Police Department, the Middletown Police Department, and the FBI. All three cases were highly publicized in the media.

Recovered Firearm – A U.S. Postal Service employee found a handgun along Canal Road and River Ridge Lane. Officers recovered the firearm and learned that it had been entered as a stolen gun. BCSO Detectives took possession of the stolen firearm for their case.

Felony Domestic Violence – Officers responded to the 1800 block of Allstatter Avenue for an active Domestic Violence incident. An adult male had reportedly struck his child's mother in the head several times before fleeing the area on foot. Officers located the suspect fleeing into Hamilton near the Five Points roundabout, and he was arrested, charged with Felonious Domestic Violence, and booked into the BC Jail.

Impaired Driver – Evening Shift officers responded to Flying Ace Car Wash on Winford Avenue for a female driver who was passed out behind the wheel. Officers determined the driver was impaired and discovered drug contraband. The officers arrested her and charged her with OVI and Drug Paraphernalia.

Stolen Vehicle/Pursuit – Officers responded to Speedway, 3450 Tylersville Road, for a report of a stolen vehicle in the lot. Officers arrived and attempted to stop the suspect/vehicle; however, the suspect refused to stop, leading to a pursuit. The pursuit was later terminated, and Mason PD found the stolen vehicle in their jurisdiction the next day.

Fight/Assault – Evening Shift officers responded to North Fairfield Baptist Church, 6853 Gilmore Road, for a fight/assault. During a juvenile basketball game, two parties were discussing their child when another male subject intervened and assaulted the male victim. Officers identified the male suspect and signed an arrest warrant for him.

Suicide Attempt/Injury Crash – Midnight Shift officers responded to SR 128 (Hamilton Cleves Road) for a vehicle that struck a utility pole. The investigating officers learned that it was not an accident, and the male driver was attempting to commit suicide after family members reported him as a critical missing person out of Colerain Township (Hamilton Co.) Colerain Township PD took custody of the male, who reportedly sought mental health treatment after the crash.

Trespassing/Prowlers/Juvenile Complaint – On December 6th, during nighttime hours, several residents reported two unidentified black males kicking front doors to homes in the area. The juveniles fled before officers arrived.

Drone Training Completed – Officers Trenton Smith and David Caldwell obtained their FAA Part 107 Remote Pilot Certification. Beyond the basic FAA Part 107, they will attend a structured public safety training program that focuses on skills, competence, and the specific demands and safety protocols of emergency response.

Drugs – Day Shift officers conducted a traffic stop of a pickup truck in the Walden Ponds neighborhood for speeding. During the stop, the driver claimed he was trying to help a friend's grandmother who needed medical aid. Upon further investigation, officers located drugs and contraband in the driver's possession. Charges are pending lab analysis of the drugs.

Fight/Criminal Damaging – Day Shift officers investigated a fight between two male individuals at Dollar General, 3315 Stephens Drive, and one of the individuals was reported to have a handgun. Officers learned that the male suspect became upset when the other male, a repo driver, took his car. This resulted in confrontation, and the suspect damaged the tow truck. Officers issued the suspect a summons for Criminal Damaging and released both parties without incident.

Crash/OVI – Day Shift officers responded to the 5800 block of Reigart Road for a vehicle into a ditch. Upon arrival, officers identified the driver, who was impaired/intoxicated. Due to the high level of intoxication, officers could not complete field sobriety testing. Officers arrested the male driver, charging him with OVI and Failure to Control a Vehicle. He also had a prior OVI conviction in 2023.

Overdose/Drugs – Officers responded to the 1900 block of Fairfax Avenue for a female not breathing. The female was overdosing, and officers located drugs at the scene. Medics transported the female, and all drugs are undergoing analysis at Miami Valley Crime Lab. Charges are pending lab results.

Training – Officer Corey Stebbins completed the Ohio Peace Officer Training Academy (OPOTA) Instructional Skills Course. This training covers teaching methods, lesson planning, and other skills to teach departmental continuing education and specified courses at the basic police academy.

Evidence Technician Training – Detective Mitchell Williams attended the two-week Evidence Technician Certification program at the Miami Valley Crime Laboratory. This training was free due to our agency being a member of the MVRCL.

Donations – Evening Shift Patrol Officers collected more than 60 pairs of socks, which they donated to New Life Mission in Hamilton for people in need.
