Officers represented the police department by participating in the City of Hamilton 4th of July parade and the Annual Meadows of Indian Springs Bike Parade.

Members of the police department attended the Lane Library Groundbreaking ceremony.

The police department parked a vehicle at the fairgrounds to showcase during the week of the Butler County Fair.

The Ohio Department of Veterans Services came to the police station to conduct an on-site visit during the final approval of the police department being an approved agency for military members/veterans to obtain benefits for on-the-job training.

Sergeant Viel and Officer Thompson attended SWAT 1 Training held locally. Both were recently selected as members of the BC Regional SWAT Team following an extensive tryout and selection process.

Detectives responded to several unnatural deaths throughout the month. A detective is assigned to every unnatural death case and works with the Coroner's Office. Examples of an unnatural death include overdose, accident, and suicide.

July 1 – Evening Shift officers found and discovered a stolen license plate on a vehicle near AAA Storage off of Gilmore Road. The officers recovered the stolen license plate.

July 3-5 – Officers worked traffic enforcement details during the 4th of July Traffic Blitz to enforce OVI laws and arrested two OVI offenders during traffic stops. The overtime is paid through the ODPS Impaired Driving Enforcement (IDEP) Grant.

July 9 – Detectives conducted a search warrant in the 3000-block of Springcrest Drive relating to a child pornography investigation. This case remains under investigation.

July 10-11 – Captain Lanier attended a two-day free FEMA training on UAV Flight Operations Level II and Data Analytics Level II. This training ties in to working with other agencies and GIS mapping during a disaster.

July 11 – Officers Stebbins, Thompson, and Claros made a visit to KinderCare’s Summer Camp and spent some quality time with the kids and the staff. We are thankful for their invitation.

July 11 – Detectives identified a male suspect who distracted a salesclerk at Game Stop in Bridgewater Falls before grabbing a Nintendo Switch then running outside with the merchandise. Detectives charged Jordon Todd Dominique with Theft.

July 12 – In collaboration with the BC OVI Task Force, a checkpoint was held on SR4 at Indian Meadows Drive. This checkpoint resulted in two drug-related OVI arrests.

July 21-25 – Officers worked grant paid traffic enforcement overtime through the ODPS Selective Traffic Enforcement (STEP) Grant during the annual “Speed Enforcement Week.” Officers working those grant hours issued 21 speeding citations during that time period, in addition to other violations.

July 28 – Detectives conducted a search warrant in the 7000-block of Wildbranch Road following an investigation into Domestic Violence, Endangering Children, and Having Weapons Under Disability. Detectives seized two firearms from the apartment and arrested a male subject pertaining to this investigation.

July 29 – Officers responded to Panera in Bridgewater Falls for a report of a male subject exposing himself inside the restaurant. Officers investigated the complaint and arrested the subject for Public Indecency. The subject had a prior conviction for the same offense back in 2021.

July 30 – Day Shift officers responded to the 3700 block of Schroeder Drive for a reported kidnapping. Officers issued a BOLO and spent a generous amount of time trying to locate the alleged victim as the investigation continued. Detectives determined that the male suspect, Patrick Edsall, faked his kidnapping to extort money from a relative for drugs. Edsall also left his 7-year-old son home all night by himself. Edsall is charged with Theft by Deception from a Person in a Protected Class (F-5), Endangering Children (M-1), and Inducing Panic (M-1). His charges are pending in the Butler County Grand Jury.
