Detective Meghan Robinson completed the Reid Interview and Interrogation Training in Troy, OH from June 24 through June 27.

Sergeant Ryan Roach taught at the annual Ohio Tactical Officers Association (OTOA) in Northern Ohio the week of June 9.

Officer Richard Coy attended a joint police bicycle training course with Butler County Sheriff's Office bike deputies on crowd control on June 19.

The 30th Annual Respect for Law Camp took place with the campers graduating on June 22, 2025. FTPD represented and had three employees who participate in support and platoon leadership roles.

The property room was equipped with the updated storage system for evidence and property.

Evening Shift officers took a theft report in the 4000-block of Schroeder Drive for a handgun stolen out of the victim's vehicle. Officers entered the stolen weapon into the National Crime Information Center (NCIC) database.

Detectives, working with Cincinnati Police Department, served a search warrant on Allstatter Avenue. Detectives arrested JOSHUA DALHOVER after a significant marijuana seizure. Investigators also seized a firearm, other drug contraband/paraphernalia, and suspected drug assets per a search warrant.

Midnight Shift officers discovered a male with a gunshot wound to his head near the Butler Tech fire tower off Millikin Road. Investigators responded and determined through evidence that the wound appeared to be self-inflicted. The victim succumbed to the injuries at West Chester Medical Center.

Day Shift officers arrested MOLLIE J. GABBARD after responding to the 2700-block of Hamilton Mason Road for an Unknown Trouble call. Officers found GABBARD possibly under the influence of drugs. Paramedics also responded to the scene. GABBARD assaulted a paramedic while they were trying to help her. Officers charged GABBARD with Assault (F4), Resisting Arrest, and Misconduct at an Emergency and booked her into jail.

Midnight Shift officers arrested DEANDRE RAMONDO HAGGARD for OVI after finding him slumped over the steering wheel at the intersection of Liberty Fairfield Road at State Route 4 (Hamilton Middletown Road). HAGGARD refused to submit to a blood test when asked by officers. HAGGARD's charges of OVI are pending in Butler County Area 2 Court.
