Firearms and Arrests – Officer Claros stopped a vehicle for a traffic violation during the midnight shift. He furthered his investigation of the two males in the car and learned both had arrest warrants. He saw that the vehicle was associated with a stolen firearm call earlier this summer. When he took the passenger into custody, he found a loaded handgun with an extended 33-round magazine in the subject's waistband. Officers also arrested the driver and located a loaded AR-15 pistol within reach of the driver's seat. Both subjects are known as gang members and were charged with additional felony firearms charges.

Felony Arrest – Officers arrested James Saylor for failure to appear on warrants related to charges of Breaking and Entering, Vandalism, Possession of Criminal Tools, and Theft. These warrants stem from an investigation and Saylor's arrest earlier this year for breaking into AG Station & Food Mart.

Public Indecency – Detectives arrested Brandon Kuhlenberg following an investigation where he was alleged to have inappropriately touched himself while driving south on SR4-Bypass next to a school bus loaded with students. He was booked into the BC Jail for Public Indecency (M1).

Rape Suspect Arrested – A dayshift patrol officer was on patrol near Tuley Road when the officer recognized a wanted rapist walking down the road. The officer took the suspect into custody before he could react and booked him into the BC Jail on three (3) Rape warrants and a Strangulation warrant. While in the booking area of the BC Jail, the male became violent and assaulted several Butler County Corrections Officers.

DV Arrest – Officers responded to the 7700 block of Wildbranch Road for a Domestic Violence report. The female victim was found to have been thrown onto a staircase and strangled by a male family member who fled the scene shortly after the incident. Officers searched the area and located the suspect hiding behind a nearby apartment. He was arrested and booked in the BC Jail for Domestic Violence and Strangulation.

Threats – Officers responded to the Fairfield Preparatory Academy for reports of a student threatening to kill other students at the school. With the assistance of the Investigations Section, several students, witnesses, and staff members were interviewed before officers met with the suspect and his guardian. The suspect was charged with Aggravated Menacing and released to his guardian. He is currently expelled from the Academy.

Scam – The police department took a report from a 67-year-old woman who lost \$88,000 in a cryptocurrency scam. The police department immediately reached out to Ohio BCI's Electronic Financial Investigations unit, and their investigators were able to trace and freeze some transfers, recovering \$36,000 of the original amount. The police department and other entities continue to address crime with extreme urgency, especially those where the victims are older adults and the elderly.

Dangerous Animal Incident – Officers responded to the 1800 block of Milton Street for a resident being attacked by two pitbull dogs. Officers arrived and learned the victim escaped into his home but sustained serious injuries to his arm. The two pitbulls were his pets and were found to be currently fighting to the death in the front yard. Officers deployed an Electronic Immobilization Device (Taser) on the dogs to separate them and safely evacuate the victim to an ambulance. The more aggressive dog was captured and handed over to the Butler County Animal Warden. The other pitbull was confined to the victim's property at the request of the owner.

Aggravated Menacing with a Gun – Officers responded to the 2100 block of Fairfax Avenue for an individual requesting help due to someone pointing a gun at him. The caller disconnected without leaving an address, and officers canvased the area and located him hiding inside a nearby house. The victim reported that a man had pointed a handgun at him and threatened to kill him. The suspect was identified, and a warrant was issued for his arrest. Evening Shift officers located the suspect later that evening and booked him into the BC Jail for Aggravated Menacing.

Burglary and Stolen Vehicle – Officers responded to Echo Springs for a burglary and vehicle theft report. The resident woke up to find their vehicle had been stolen from their garage during the night. The vehicle was located later that day in Cincinnati and returned to the owner. This case remains under investigation.

Pursuit – An evening shift officer attempted a traffic stop on a vehicle for traveling close to 100 mph. The driver failed to stop, leading to a short vehicle pursuit. Due to high speeds and concern for public safety, the pursuit was terminated. A short time later, a Butler County Sheriff's Office Deputy located the vehicle. The driver was arrested and charged with Failure to Comply, Tampering with Evidence, and multiple traffic offenses.

Scam – Evening shift took a report of a victim who applied for a grant to help pay off debt and received a fraudulent check for over \$19,000 from a scammer. She was instructed to deposit the check and convert funds into Bitcoin. The victim's bank identified the check as fraudulent and stopped all transactions.

Flock Camera Activity – Officers located a vehicle with a stolen license plate. The driver was arrested and booked into the BC Jail for Receiving Stolen Property (F5) and Fictitious Plates.

Flock Camera Activity – Officers located the driver of a vehicle who had active warrants for Felonious Drug Possession. The driver was arrested and booked into the BC Jail for those warrants.

Initiative – Officer Fugett spearheaded the "Pink Patch" initiative for officers' duty vests. Officers paid money to buy the patches and proudly wore the patches throughout the month in support and memory of those affected by breast cancer. The slogan for the month was, *"We Got Your Back."*

Theft – Officer Sizemore responded to McDonald’s for an employee who reported her purse as being stolen from inside the restaurant. Officer Sizemore collected surveillance footage and identified a female suspect. With assistance from Detective Robinson, a social media post was created featuring the suspect from the video. Within 24 hours, multiple tips were received identifying the suspect. She was later arrested and charged with Theft.

Breaking and Entering – Officers responded to a B&E in progress at a business on Tylersville Road. The Officers located a suspect in the area and recognized him as the suspect of a breaking and entering at the same business the day before. Officers arrested the suspect and booked him into the BC Jail for multiple charges related to the Breaking and Entering and Theft for both incidents.

Breaking and Entering – Officers responded to a B&E in progress on Fairfax Avenue. The homeowner heard a noise in another area of the house and found several teenagers trying to enter the house through a window. She was able to secure the house, and the suspects took off.

Juvenile Complaint – Officers responded to the area of Wildbranch Road and Crooked Tree Circle for a report of a juvenile pointing a firearm at other children. Officers canvassed the area and located a firearm in a nearby creek, but later determined it was an airsoft gun. The juvenile was arrested and charged with Inducing Panic and Disorderly Conduct for his actions.

Training – Sergeant Miller and Sergeant Roach taught High Risk Vehicle Engagements to the road patrol officers. The training consisted of techniques and tactics for taking a dangerous individual into custody while on a traffic stop and extracting uncooperative suspects from a vehicle.

Training – Captain Lanier participated in a county-wide joint drone training hosted by West Chester PD at Voice of America. Various agencies throughout Butler County collaborated on foundational flight skills and drills, scenario-based exercises with an emphasis on real-world applications, and both daylight and nighttime operations.

Training – Fairfield Township hosted the Butler County Regional SWAT Team for scenario training at a vacant property.
