The police department hosted a one-week Police Mountain Bike Patrol training course. FTPD Officer Richard Coy, an IPMBA certified training officer, led the course with seven officers in attendance from four different agencies.

On May 28-29 Sergeant Brandon McCroskey attended the second session for Certified Law Enforcement Executive (CLEE) at Ohio Highway Patrol Academy in Columbus, Ohio.

Fairfield Township Officers completed a 1-day training program on pistol optics ("sights") at the Butler County Sheriff's Office Range on Woodsdale Road. The Fairfield Township Range Staff taught this entire training program to all personnel who attended.

Detectives arrested Philip F. Hartsfield of Decatur, AL for Kidnapping (F1), Rape (F1), and Robbery (F2.) All the charges are pending in Butler County Common Pleas Court.

Evening Shift Patrol officers found a stolen vehicle from Philadelphia, PA on SR4 Bypass. Officers arrested the driver of the stolen vehicle and charged the driver with Receiving Stolen Property (F4).

Evening Shift Patrol officers arrested Christina Marie Sumner and booked her into the BC Jail after she disturbed several graves decorated for Memorial Day Weekend. Her charges of Desecration (M2) and Obstructing Official Business (M2) are pending in Butler County Area 2 Court.

On May 24, patrol officers witnessed an injury crash on SR4 Bypass at SR129. The driver of the at-fault vehicle ran a red light before and was struck by pick-up truck. The at-fault driver was ejected from the vehicle, landed in the roadway, and sustained severe, life-threatening injuries. Air Care transported the 88-year-old driver to University of Cincinnati Hospital. The other driver had minor injuries.

Midnight Shift officers charged a female driver for Grand Theft (F4) after she stole a friend's vehicle from La Cazuela on Princeton Road, drove the vehicle while impaired, then got into a crash in the city of Hamilton. Charges are pending in Area 2 Court.

On May 30, 2025, Midnight Shift officers arrested a suspect on James Place for Burglary (F4) after a male suspect entered a stranger's residence without consent. The homeowner spotted the male suspect in their home and called the police. The Burglary charge is pending in court. The male suspect is already on parole and got booked into BCJ.

Several officers participated in the annual Click It or Ticket Enforcement Campaign. Officers worked overtime hours to enforce traffic laws, paid for through the Selective Traffic Enforcement Program (STEP) Grant. The grant is issued through the Ohio Department of Public Safety.
