Dear Shelly:

This is to advise that an ACH payment in the amount of \$25,346.57 in payment of Fairfield Township's net collections for the J.E.D.D. I, II, and III will be forthcoming. This is in accordance with the J.E.D.D. Board Directive September 1, 2005 to have the distributions made monthly.

For the calculations pertaining to the balance for distribution of funds for **October 2021** we now have the original J.E.D.D. (categorized as J.E.D.D. I), the first amendment adding area to the original J.E.D.D. (categorized as J.E.D.D. II), and the second amendment adding additional area to the original J.E.D.D. (categorized as J.E.D.D. III). The total available for distribution (net of refunds and commissions) for October 2021 for J.E.D.D. I is \$39,797.62 (See J.E.D.D. I collections attachment). The J.E.D.D. agreement determined that the distributions for J.E.D.D. I will be paid 75% to the City of Hamilton and 25% to Fairfield Township. The distribution according to that criteria would result in a payment of \$29,848.21 to the City of Hamilton and a payment of \$9,949.41 to Fairfield Township.

**The JEDD I October 2021 Collections have been reduced by Partial Estimated 2021 CCA Fees in the amount of \$13,539.40**

The total available for distribution (net of refunds and commissions) for October 2021 for J.E.D.D. II is \$16,775.98 (see J.E.D.D. II collections attachment). The J.E.D.D. agreement determined that the distribution for J.E.D.D. II will be paid 25% to the City of Hamilton and 75% to Fairfield Township. The distribution according to that criteria would result in a payment of \$4,194.00 to the City of Hamilton and a payment of \$12,581.98 to Fairfield Township.

**The JEDD II October 2021 Collections have been reduced by the September 2021 Negative -\$3,309.49**  
**The JEDD II October 2021 Collections have been reduced by Partial Estimated 2021 CCA Fees in the amount of \$11,668.83**

The total available for distribution (net of refunds and commissions) for October 2021 for J.E.D.D. III is \$5,630.35 (see J.E.D.D. III collections attachment). The J.E.D.D. agreement determined that the distribution for J.E.D.D. III will be paid 50% to the City of Hamilton and 50% to Fairfield Township. The distribution according to that criteria would result in a payment of \$2,815.17 to the City of Hamilton and a payment of \$2,815.18 to Fairfield Township.

**The JEDD III October 2021 Collections have been reduced by the September 2021 Negative -\$448.15.**  
**The JEDD III October 2021 Collections have been reduced by Partial Estimated 2021 CCA Fees in the amount of \$353.77**

The total combined amount due to the City of Hamilton is \$36,857.38. The total combined amount due to Fairfield Township is \$25,346.57.
