**RESOLUTION TO AUTHORIZE PAYMENT FOR THE INDIGENT CREMATION OF  
A TOWNSHIP RESIDENT TO BROWN DAWSON FLICK FUNERAL HOME

**WHEREAS:** The resident, who was deceased in the Township and did not qualify for public assistance or reside in a county home, is eligible for aid with burial expense pursuant to RC 5101.52; and

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

**SECTION 1:** The Board hereby authorizes the payment to for the Indigent Cremation of a Township resident (Arthur F. Meredith) to Brown Dawson Flick Funeral Home, 330 Pershing Avenue, Hamilton, OH 45011, in the amount of \$500.00, paid from Fund No. (1000) and included herein as Attachment A.

**SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.




