RESOLUTION APPOINTING FISCAL OFFICER.

WHEREAS, the position of Fiscal Officer of Fairfield Township is currently vacant and became vacant November 29, 2017; and

WHEREAS, pursuant to Ohio Revised Code §503.24, the Board of Trustees shall appoint a Fiscal Officer having the qualifications of an elector to fill the unexpired term or until a successor is elected within 30 days of the office becoming vacant; and

WHEREAS, the Board of Trustees desires to appoint Achultz as Fiscal Officer to fill the vacancy; and

NOW, THEREFORE, BE IT RESOLVED, by the Trustees of Fairfield Township, Butler County, Ohio, as follows:

- SECTION 1: The Board of Trustees hereby appoints Achilles Schultz to serve as the Fiscal Officer of Fairfield Township for the unexpired term of the prior Fiscal Officer.
- SECTION 2: This appointment shall be effective on December 28, 2017.
- SECTION 3: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
- SECTION 4: This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- SECTION 5: This resolution is hereby declared to be an emergency measure, pursuant to RC 504.11, necessary for the immediate preservation of the public peace, health, safety, or welfare of the residents of Fairfield Township.
- SECTION 6: That the Board by a majority vote hereby dispenses with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of the Resolution upon its first reading.
- SECTION 7: This resolution shall take effect at the earliest date allowed by law.
