## RESOLUTION TO AUTHORIZE THE PURCHASE OF A BACKHOE DITCH BUCKET TO FIT CASE #580SMII FROM SOUTHEASTERN EQUIPMENT FOR THE ROAD DEPARTMENT, IN THE AMOUNT OF \$1,500.00.
