RESOLUTION TO AUTHORIZE PURCHASE OF (2) TWO 2017 FORD POLICE INTERCEPTOR UTILITY VEHICLES FROM LEBANON FORD, AT A TOTAL COST OF \$53,560.00, ATTACHED HEREIN AS EXHIBIT A.

WHEREAS: A need has been determined to replace and rotate (2) police vehicles; and

WHEREAS: State bid pricing was utilized; and

WHEREAS: It will be taken out of the Safety Service Fund No. 2081;

BE IT RESOLVED, by the Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board of Trustees, hereby, authorizes the purchase of (2) two 2017 Ford Police Interceptor Utility Vehicles from Lebanon Ford, 770 Columbus Avenue, Lebanon, OH 45036, at \$26,780.00 each for a total cost of \$53,560.00, attached herein as Exhibit A.

SECTION 2: The Trustees of Fairfield Township do hereby dispense with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and do authorize the adoption of this resolution upon its first reading.

SECTION 3: This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.
