

**FAIRFIELD TOWNSHIP
RESOLUTION NO. 17-73**

RESOLUTION APPOINTING ROBERT CHABALI AS POLICE CHIEF

WHEREAS, the position of Police Chief of Fairfield Township is currently vacant; and

WHEREAS, the Board of Trustees is required to appoint a Police Chief pursuant to Section 505.49 of the Ohio Revised Code for the efficient administration and enforcement of laws, where a township police district is established; and

WHEREAS, the Board of Trustees believes Robert Chabali is well qualified for the position of Chief; and

WHEREAS, the Board of Trustees has determined that Robert Chabali has demonstrated possession of the necessary, education, skills, training, and experience to effectively carry out the policies established by the Board of Trustees as Police Chief for Fairfield Township.

NOW, THEREFORE, BE IT RESOLVED, by the Trustees of Fairfield Township, Butler County, Ohio, as follows:

SECTION 1: The Board of Trustees hereby finds that Robert Chabali is well qualified for the position of Chief of Police, and specifically finds that he has the qualifications previously specified by the Township for that position, and his appointment is in compliance with Section 505.49 of the Ohio Revised Code.

SECTION 2: The Board of Trustees hereby appoints Robert Chabali to the position of Chief of Police of Fairfield Township pursuant to Section 505.49 of the Ohio Revised Code.

SECTION 3: Robert Chabali will serve at the pleasure of the Board. His annual salary shall be \$91,000.00, and he shall receive the same benefits as other full time employees of the Township. In addition to his salary, he shall receive a take-home vehicle for transportation, an \$800.00 uniform allowance, and a \$50.00 monthly stipend for his cellular telephone. His benefits and salary may be reviewed and modified from time to time as the Board may determine.

SECTION 4: This appointment shall be effective on August 7, 2017, provided that Robert Chabali has taken his Oath of Office by that time.

SECTION 5: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 6: That the Board by a majority vote hereby dispenses with the requirement that this Resolution be read on two separate days and hereby authorizes the adoption of the Resolution upon its first reading.

SECTION 7: This resolution shall take effect at the earliest date allowed by law.
