Jim Lupidi was initially appointed via motion on 10/8/2014 to be a member on the Zoning Appeals Board to the unexpired term of Richard St. John. Mr. St John's term was set to expire 9/19/15. J. Lupidi was reappointed on 1/20/2016 for a 5 year term that was set to expire 1/31/2021 (Res 16-13). Looking at the historic term schedule of the seat that J. Lupidi was appointed the term should be scheduled to expire in 2020.

Staff recommends changing the date the for Jim Lupidi's term expire to 1/31/2020.

Weeks would be due for reappointment this year.
