**RESOLUTION TO AUTHORIZE PAYMENT FOR THE INDIGENT CREMATION OF A  
TOWNSHIP RESIDENT TO COLLIGAN FUNERAL HOME IN THE AMOUNT OF \$500.00.**

**WHEREAS:** The resident, who was deceased in the Township and did not qualify for public assistance or reside in a county home, is eligible for aid with burial expense pursuant to RC 5101.52;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

**SECTION 1:** The Board hereby authorizes the payment for the Indigent Cremation of a Township resident (Leslie Eugene Newton) to Colligan Funeral Home, 437 South 3<sup>rd</sup> Street, Hamilton, OH 45011, in the amount of \$500.00, paid from Fund No. 1000 and included herein as Attachment "A".

**SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

**SECTION 3** This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

**SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

**SECTION 5:** This resolution shall take effect at the earliest period allowed by law.
