FAIRFIELD TOWNSHIP RESOLUTION NO. 18-150

RESOLUTION TO AMEND THE 2018 PERMANENT APPROPRIATIONS.

WHEREAS: the Board of Trustees has determined that making repairs to Gilmore Road will contribute to the health, safety and welfare of the residents of Fairfield Township and will promote economic development; and

WHEREAS: the Board desires to appropriate \$600,000 from the 2906 Princeton Road TIF Fund and \$205,278.00 from the 4903 Fairfield Township RID Capital Projects Fund to pay for such repairs; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- **SECTION 1:** The Board hereby authorizes the amendment to the 2018 Permanent Appropriations, as listed on the attached Exhibit "A".
- **SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- **SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
- **SECTION 5:** This resolution shall take effect at the earliest period allowed by law.
