RESOLUTION TO APPROVE THE PURCHASE OF PLAYGROUND EQUIPMENT FROM GAME TIME, IN THE AMOUNT OF \$179,975.00.

WHEREAS: The Board of Trustees approved the creation of a volunteer parks committee to evaluate and make recommendations for the Township parks; and

WHEREAS: The Committee recommended new playground equipment at the Shaffer's Run Community Park, for 2018; and

WHEREAS: It was determined that Game Time was the most reasonable and responsive vendor; and

WHEREAS: Game Time offers a grant of \$48,889.87 and uses a Federal Co-op which compares to State bid and eliminates the need to bid the equipment; and

WHEREAS: The Parks Committee & Administration recommend Game Time; and

WHEREAS: This will be purchased out of Fund No.'s 1000-610-599-1020 and 1000-610-599-1013.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- SECTION 1: The Board hereby approves the purchase of playground equipment from Game Time, in the amount of \$179,975.00, and authorizes the Administrator to execute the Sales Quotation attached hereto as Exhibit "A".
- SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.


