# RESOLUTION TO APPROVE FIRE DEPARTMENT PURCHASE OF EQUIPMENT FOR SWIFTWATER RESCUE FROM MATNEY ENTERPRISES INC., AT A TOTAL COST OF \$4,168.50.

- **SECTION 1:** The Board hereby approves Fire Department purchase of equipment for swift water rescue from Matney Enterprises Inc., 246 Locust Grove Road, Greensburg, KY, 42743, at a total cost of \$4,168.50, attached hereto as Exhibit "A".
- **SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- **SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
