**RESOLUTION AUTHORIZING BUTLER TECH TO PERFORM ALL OF THE  
LANDSCAPING WORK TO BE DONE FOR THE LARGE MEDIAN OUTSIDE OF WALMART  
ON PRINCETON ROAD IN FAIRFIELD TOWNSHIP,  
AT A COST NOT TO EXCEED \$17,500.00.**

**WHEREAS:** The landscaping labor work will be done by Butler Tech students which will benefit them by giving them experience and saves the Township significantly on cost because the labor is free; and

**WHEREAS:** This will be purchased out of Fund No.1000-360;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

**SECTION 1:** The Board hereby authorizes payment for the median on Princeton Road landscaping work to be done outside of Walmart in the amount not to exceed \$17,500.00 which will include plants and material only and the labor will be free, attached hereto as Exhibit "A".

**SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

**SECTION 3** This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

**SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

**SECTION 5:** This resolution shall take effect at the earliest period allowed by law.
