## FAIRFIELD TOWNSHIP RESOLUTION NO. 18-77

## RESOLUTION TO APPROVE THE PURCHASE OF TASERS AND ACCESSORIES FOR THE POLICE DEPARTMENT FROM VANCE'S LAW ENFORCEMENT, AT A TOTAL COST OF \$3,019.88.

WHEREAS: Fairfield Township has recently hired three new Police Officers who are currently undergoing field training; and

**WHEREAS:** The Police Chief has determined that in order to properly equip these new officers, it is necessary to purchase 2 new Tasers and accompanying accessories; and

**WHEREAS:** The total cost of the required equipment is \$3,019.88 and will be purchased out of Fund No. 2081-210-420;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- SECTION 1: The Board hereby approves the purchase of Tasers and accessories for the Police Department from Vance's Law Enforcement at a total cost of \$3,019.88, as described on the quote attached hereto as Exhibit "A".
- **SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
- **SECTION 5:** This resolution shall take effect at the earliest period allowed by law.

Mrs. Vonderhaar:

As you are aware, we have three new Officers that are in their field training phase and are in the process of being equipped with required equipment. The Taser, much like pepper spray, is a less-lethal means of subduing suspects which minimizes use of force incidents and is Township-issued required equipment.

Officer Krznarich's Taser will be reissued to one of our new Officers after his retirement on April 27. As our authorized strength has increased by two, we need to purchase the following Taser equipment to properly equip the remaining two Officers (1 Taser is always kept as a backup):

- · 10 field cartridges
- 2 targets
