

**FAIRFIELD TOWNSHIP

**RESOLUTION APPROVING THE PURCHASE OF FENCING TO BE INSTALLED AROUND
THE RECYCLE BINS AT THE POLICE DEPARTMENT FROM ROBINSON FENCE
COMPANY IN THE AMOUNT OF \$3,995.00.**

WHEREAS: The recycle area on Vonnie Vale Court in front of the Police Department is in need of fencing to surround the recycle bins to avoid trash being strewn all over the parks area and to make it more aesthetically pleasing; and

WHEREAS: Fairfield Township will be splitting the cost with Butler County Waste and Recycling;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby approves the purchase and installation of fencing from Robinson Fence Company in the amount of \$3,995.00, to be paid from Fund No. 1000-610-599-1020, as set forth on the invoice, attached hereto as Exhibit "A" .

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.
