FAIRFIELD TOWNSHIP RESOLUTION NO. 19-07

RESOLUTION DESIGNATING FAIRFIELD TOWNSHIP ROADS FOR BIDS ON THE ATTACHED PAVING ESTIMATES LIST FOR RESURFACING AND RETRACING AS (ATTACHMENT "A"), TO BE CERTIFIED FOR FUNDING UPON THE AWARDING OF CONTRACTS FOR ROAD IMPROVEMENTS, WITH A COST NOT TO EXCEED \$425,000.00.

WHEREAS: Butler County is able to receive discounting on resurfacing and retracing for roadways with the County; and

WHEREAS: Butler County has provided Fairfield Township an estimate based on desired 2019 work, with said estimate subject to change upon selection of bid by Butler County; and

WHEREAS: Butler County has requested that all Township Resolutions to be completed and returned for inclusion in the county contract; and

WHEREAS: The Fairfield Township paving list for 2019 totals \$425,000.00;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- **SECTION 1:** The Board hereby designates 2019 Fairfield Township roads for bids as set forth on the attached paving estimates list for resurfacing and retracing as seen herein as attachment "A", to be certified for funding upon the awarding of contracts for road improvements with a cost not to exceed \$425,000.00 paid from the General Fund (#1000).
- **SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- **SECTION 3** This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- **SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.
