**RESOLUTION TO AUTHORIZE THE PURCHASE OF THREE IN-CAR CAMERA SYSTEMS
AND SOFTWARE EQUIPMENT FOR THE THREE NEW POLICE DEPARTMENT SUV'S
FROM WATCHGUARD, IN THE TOTAL AMOUNT OF \$28,035.00.**

WHEREAS: It has been determined there exists a need to purchase in-car camera systems and software equipment for the three new police department SUV's; and

WHEREAS: The cost for the three in-car camera systems and software equipment totals \$28,035.00; and

WHEREAS: The in-car camera systems and software will be purchased out of Fund No. 2191;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby authorizes the purchase of three in-car camera systems and software equipment for the three new Police Department SUV's from WatchGuard, in the total amount of \$28,035.00, as set forth on the attached Exhibit "A".

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.
