**RESOLUTION TO AUTHORIZE INSTALLATION OF EQUIPMENT FOR THE THREE NEW
POLICE DEPARTMENT SUV'S FROM P & R COMMUNICATIONS SERVICE, INC.,
IN THE TOTAL AMOUNT OF \$52,797.00.**

WHEREAS: The Police Chief has recommended outfitting of the three new Police Department vehicles with various pieces of new equipment as the old equipment cannot be retrofitted to the new vehicles; and

WHEREAS: The Board has received a quote from P & R Communications Service, Inc. for the installation of such equipment at a total cost of \$52,797.00; and

WHEREAS: This will be purchased out of Fund No. 2191:

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby authorizes the installation of equipment for the three new Police Department SUV's by P & R Communications Service, Inc., in the total amount of \$52,797.00, as set forth on the attached Exhibit "A".

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.



SECTION 5: This resolution shall take effect at the earliest period allowed by law.







Project Summary

X3 – 2020 FORD POLICE INTERCEPTOR SUV'S

FEDERAL SIGNAL:

Install new 53" Allegiant 2-color light bar with low hook kit centered on the "T"

Install PF200 w/ 17 button controller with UDPD programming template *Park Kill*

Install one 100 watt siren driver behind the grill w/ bracket

Install Rumbler Kit w/ specific brackets

Install OBD cable and run to the rear of the vehicle

Install 2 dual color steady burn MicroPulse LED's – red with the brake lights – flanking the rear license plate

Install two 2-color 4-head CN SignalMasters – blue/white on the push bumper, red/blue in the rear window – red with the brake. Install kits were ordered for each setup.

Install 4 IMPAXX blue/white – 2 (one on each side of the push bumper) + 2 (one in each of the rear side windows using RSW brackets)

Install 1 round blue LED's on the underside of the tailgate w/ mercury and on/off switch.

Install three 3" round red/white LED's- 1 one the underside of the tailgate with on/off switch and 2 in the prisoner containment area above each seat (switch on Pathfinder)

SoundOff Signal:

Install Blue/White nLINE side running board lights activated in position 2 and 3

Install 4 Blue mPOWER LED's mounted in the grill cutouts

Install 2 Blue/white twist LED's in the headlights with collars and 2 Blue in the taillights

HAVIS

Install new 22" Havis console with built in brother printer cutout, arm rest and cup holders, USB plate and AP

Install new passenger side computer mount and use NEW Havis Dell docking station and power supply

Install premium cargo tray and cargo floor per instructions and mount all equipment on the tray

PROGARD

Install Polycarb center slider front partition with recessed panel and kick plates per instructions

Install Polycarb rear cargo barrier w/ prisoner seat and OUTBOARD seat belt system per instructions

Install window bars w/ OEM door panels

Install heavy duty push bumper w/ 2 blue/white LED's

Santa Cruz:

Install 3 universal weapon racks w/ handcuff locks — 2 in recessed housing up front and 1 in the rear for less lethal with additional push button release in the rear. (Customer marked locations)

D&R:

Install PDU on Havis equipment mounting tray.

Magnetic Mic:

Install 2 magnetic mic clip on the right side of the console w/ brackets
