**RESOLUTION TO AUTHORIZE THE ADMINISTRATOR TO EXECUTE ALL PURCHASES  
AND CONTRACTS FOR AMOUNTS OF \$5,000.00 OR LESS.**

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

**SECTION 1:** The Board hereby, authorizes the Township Administrator to execute all purchases and contracts for amounts of \$5,000.00 or less.

**SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

**SECTION 3** This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

**SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

**SECTION 5:** This resolution shall take effect at the earliest period allowed by law.

## Fiscal Note & Local Impact Statement

**Bill:** H.B. 500 of the 132nd G.A.

**Status:** As Introduced

**Sponsor:** Rep. Carfagna

**Subject:** Makes various changes to the township law

---

### Fiscal Highlights

- The bill allows a township to include levies for police, fire, EMS, and ambulance service to the list of levies that must be reimbursed from payments in lieu of taxes from properties that are tax exempt under tax increment financing (TIF) arrangements.
- The bill allows the costs of maintaining capital improvements funded by certain TIFs to be paid from TIF revenue. Townships that use TIF revenue for maintenance costs may reduce expenditures from funds otherwise used to pay those costs.
- The bill authorizes townships to levy an admissions tax of up to 5% of the cost of admission to certain events occurring within the township.
- The bill authorizes townships to expend up to \$50,000 to erect memorials to veterans that died in service to the United States or to Ohio. Current law allows townships to expend up to \$5,000 for these memorials.
- The bill increases the amount of debt that a board of township trustees may authorize an officer or employee to incur on behalf of the township from \$2,500 to \$10,000.
