**RESOLUTION ADOPTING THE 2020 PERMANENT APPROPRIATIONS BY ATTACHED  
FUND TOTALS FOR FISCAL YEAR COMMENCING JANUARY 1, 2020.**

**WHEREAS:** The Permanent Appropriations must be approved no later than the end of March 2020; and

**WHEREAS:** The Board at this time desires to approve Permanent Appropriations for Fairfield Township; and

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

**SECTION 1:** The Board hereby adopts the Permanent Appropriations Budget for fiscal year commencing January 1, 2020, a copy of which is attached as Exhibit "A" and made a part of this resolution by reference.

**SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

**SECTION 3** This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

**SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

**SECTION 5:** This resolution shall take effect at the earliest period allowed by law.
