FAIRFIELD TOWNSHIP RESOLUTION NO. 19-27

RESOLUTION AUTHORIZING THE PURCHASE OF RIFLES FOR THE POLICE DEPARTMENT FROM VANCE'S LAW ENFORCEMENT, AT A COST OF \$29,959.50.

WHEREAS: The Police Chief has recommended in order to modernize our patrol rifle program, to have one standard rifle manufacturer for all FTPD patrol personnel to have more consistency and to promote the health, safety and welfare of FTPD Officers and residents; and

WHEREAS: The rifles will be purchased out of Safety Service Fund No. 2191;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- **SECTION 1:** The Board hereby authorizes the Police Chief to purchase Rifles for the Police Department from Vance's Law Enforcement, at a cost of \$29,959.50, attached hereto as Exhibit "A".
- **SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
- **SECTION 5:** This resolution shall take effect at the earliest period allowed by law.

Mrs. Vonderhaar:

As we continue to review issues within the Fairfield Township Police Department, I have the same concerns with our personnel's patrol rifles as I did with the issued pistols, which were trade purchased in July 2018 (report authored May 31, 2018). Our personnel are either issued government surplus patrol rifles through the Law Enforcement Support Office (LESO) 1033 Program or use their own purchased patrol rifles. Our current inventory reveals that while all rifles are the proper .223 caliber ideal for patrol officers, we have a hodgepodge of rifle manufacturers issued to our personnel. Some of the personnel who own their own rifles have also purchased their own scopes. The different manufacturers include Colt (LESO government issued), Armalite, Bushmaster, Daniel Defense, Smith and Wesson, Anderson MFG, Sig, and Del-Ton. While the option to have personnel purchase their own rifle is adequate at best, it is not the most desired option, could result in liability and should be streamlined much like we streamlined the pistols in mid-2018. If you recall, we had numerous pistol calibers and manufacturers, which was not desired. After much research, we then purchased the 9 mm Glock pistol with light mounts for all personnel subsequent to your and the Trustees approval.

In order to modernize our patrol rifle program, I request approval to purchase one standard rifle manufacturer for all FTPD patrol personnel and do away with the LESO and the self-owned rifles. I note the following reasons for the purchase of these weapons:

- Other than the Colt M16 LESO rifle, there is no consistency on the manufacturer and type of rifle being used by our personnel, which makes it difficult for armorers to work on
- Not all weapons have light mounts while some personnel have purchased light mounts for their weapon all should have light mounts as they enhance citizen and officer safety
- · Not all personnel have the proper slings
- Any weapon used by an officer in an officer involved shooting would be taken off line and placed
 as evidence until litigation ends, eliminating the ability of the officer to get their weapon back in
 a timely manner
- While all current weapons are inspected and while personnel must pass a training course and
 qualify with the weapon prior to being authorized to deploy them, there is no maintenance
 information available, no accountability on number of rounds fired, age and history of the current
 weapons, which could be an issue in civil litigation as we do not have any maintenance history on
 them

In order to streamline the issued rifle and after researching the most suitable weapon for FTPD, I request approval to purchase the Sig Saur .223 caliber rifle with light mounts, vertical grips, 4 magazines and slings. I am requesting two variants to accommodate not only patrol officers, but also the officers who are assigned to the Butler County SWAT Team. The SWAT variants have a shorter barrel (11 inches versus 16 inches). While we currently have two officers assigned to the Butler County SWAT Team, the intended goal is to have a total of four as our younger personnel become more experienced. These weapons can also be used by patrol officers. I am also requesting the purchase of two EOTech sites for the current personnel assigned to SWAT. Much like the pistols, I am requesting a total of 25 in order to be able to replace weapons as the result of required maintenance, or replace weapons used in officer involved shootings.

I have attached the spec sheet for the weapons and accessories requested for your review, which total \$29,959.50.
