RESOLUTION AUTHORIZING THE PURCHASE OF LION NOMEX HOODS FOR THE FIRE DEPARTMENT FROM PHOENIX SAFETY OUTFITTERS, AT A TOTAL COST OF \$8,265.00.

WHEREAS: The Fire Chief has recommended the purchase to upgrade the quality of protection in order to contribute to the health, safety and welfare of Fairfield Township Fire Fighters; and

WHEREAS: This will be purchased out of Fund No. 2111;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby approves the purchase of (80) eighty Lion Nomex Hoods for the Fire Department from Phoenix Safety Outfitters, at a cost of \$103.00 each for a total cost of \$8,265.00, attached hereto as Exhibit "A".

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.


