RESOLUTION AUTHORIZING ISSUANCE OF THEN AND NOW PURCHASE ORDER TO DLJ MATERIAL AND SUPPLY IN THE AMOUNT OF \$7,335.00.

- **SECTION 1:** The Board hereby authorizes the purchase of crack seal at a total cost not to exceed \$7,335.00, from DJL Materials and Supply Inc., P.O. Box 5293, Akron, OH, 44334, attached hereto as Exhibit "A". This will be purchased out of Fund No. 1000.
- **SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
- **SECTION 5:** This resolution shall take effect at the earliest period allowed by law.
