# RESOLUTION TO APPROVE PURCHASE OF TASERS AND ACCESSORIES FOR THE POLICE DEPARTMENT FROM AXON ENTERPRISE, INC., AT A TOTAL COST OF \$95,940.00.

**WHEREAS:** The Police Chief has recommended this purchase of (27) Taser 7s and related accessories due to the fact that the current Tasers are becoming obsolete; and

WHEREAS: The Tasers usually have a life span of 3-5 years and the police department was advised the older models are going to be phased out and not repairable; and

WHEREAS: This will be purchased out of Fund No. 2191; and

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- SECTION 1: The Board hereby approves the purchase of Tasers and accessories for the Police Department from Axon Enterprise, Inc., at a total cost of \$95,940.00, payable in annual installments as set forth on the contract, attached hereto as Exhibit "A".
- **SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
- **SECTION 5:** This resolution shall take effect at the earliest period allowed by law.

#### Mrs. Vonderhaar:

I was recently advised by Sergeant Brandon McCroskey that our current Taser inventory, other than the two (2) X26P Tasers purchased May 9, 2018 (see attached Fairfield Township Resolution No. 18-77) are becoming obsolete. In fact, most have lost the digital readout that shows the power level, status data — year, month, hour, minute, laser flashlight on/off, and amount of time of the discharge. I also located Resolution No. 14-114, which shows that twenty-three (23) X26P Tasers were purchased July 23, 2014. Generally, these Tasers have a life span of 3-5 years, if properly maintained, making 2018 the end of their life span.

In May of this year, Officer Roger Gilbert, Officer Corey Stebblns and Sergeant Brandon McCroskey were recertified as Taser Instructors on the new Taser 7. During the training, they were advised that Taser will not be able to replace, update or fix the older X26P model much longer as they will be phased out. After research, the attached is the best option for our department – purchase price is \$95,940.00 – which can be paid in yearly increments (see attached) or payed up front. During this time, other than the holsters, the Tasers will be totally warranted and repaired without cost. Additionally, sufficient training cartridges will be provided as part of the cost.

I am requesting to purchase twenty-seven (27) Taser 7s and related accessories in order to have spares as the Taser 7 still needs to be sent to their factory for repair. Having several spares will prevent our personnel from having to go without this less-lethal technology. We have had multiple Tasers needing repair at the same time in the past.
