RESOLUTION ACCEPTING THE BUTLER COUNTY ENGINEER'S BID RECOMMENDATION IN THE AMOUNT OF \$1,435,290 FOR THE GILMORE ROAD WIDENING PROJECT AND AUTHORIZING ADMINISTRATOR TO SIGN CONTRACT AND DISPERSE PAYMENTS TO W.G. STANG.

WHEREAS: The Board of Trustees identified a need and desire to widen Gilmore Road which will contribute to the health, safety and welfare of the residents of Fairfield Township; and

WHEREAS: Butler County managed the project for the Township and received a total of 6 bids, as set forth on the attached Exhibit "A"; and

WHEREAS: Butler County reviewed all the submittals and awarded the project to W.G. Stang; and

WHEREAS: The Board of Trustees accepts the bid recommendation in the amount of \$1,435,290 for the Gilmore Road widening project and authorizes the Administrator to sign contract documents and disperse payments to W.G. Stang.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- SECTION 1: The Board hereby authorizes the payment of \$1,435,290 from Fund 4902 and 2906 for the Gilmore Road widening project and authorizes the Administrator to sign contract documents and disperse payments to W.G. Stang.
- **SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
