RESOLUTION TO AUTHORIZE PAYMENT OF \$7,336.31 FOR THE REQUIRED MATCHING FUNDS FOR THE AFG GRANT EMW-2020-FG-02630 IN THE AMOUNT OF \$80,699.40.

**WHEREAS:** The Fire Department applied for funding under the AFG Grant and has been awarded a Grant; and

**WHEREAS:** The supplies and equipment provided by this Grant will enhance the Fire Departments ability to respond to COVID related EMS calls and provide protective equipment for staff members; and

WHEREAS: The Board of Trustees has determined that accepting this AFG Grant will contribute to the health, safety and welfare of the residents of Fairfield Township;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- **SECTION 1:** The Board hereby accepts the AFG Grant EMW-2020-FG-02630 in the amount of \$80,699.40, for supplies and equipment as set forth on the attached Exhibit "A".
- **SECTION 2:** The Board hereby authorizes payment of \$7,336.31 from Fund 2281 for the required 10% Township share.
- **SECTION 3:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 4: This resolution is the subject of the general authority granted to the Board Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- SECTION 5: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
