**RESOLUTION AUTHORIZING ADMINISTRATOR TO EXECUTE AGREEMENT WITH
BUTLER TECH DONATING AMBULANCE IN EXCHANGE FOR TRAINING SERVICES**

WHEREAS: This agreement between Fairfield Township Board of Trustees and Butler Tech is intended as a sale of equipment in exchange for training resources having equal value; and

WHEREAS: The Township shall transfer to Butler Tech for its use in the school fire education program a 2010 Chevrolet Horton 4500 Ambulance S#3835; and

WHEREAS: Butler Tech will allow Fairfield Township Fire Department to use its training grounds located at 3603 Hamilton Middletown Road, to conduct training evolutions, to include the use of the driving pad for driver's training and vehicle extrication, and the training tower for evolutions which do not involve live fire;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: That the Board authorizes the Administrator to execute the agreement with Butler Tech.

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.

All training conducted by the Fairfield Township Fire Department on Butler Tech grounds shall be scheduled and conducted so as to not interfere with any training being conducted by Butler Tech's public safety education programs. Members of the Fairfield Township Fire Department are covered under the Township Bureau of Workers Compensation Plan. The Township also maintains a significant Liability Coverage. Additionally, as part of this agreement, the Fairfield Township Fire Department agrees to repair or replace any property on site shown to have been damaged during training evolutions conducted by the Department. The following land use rates apply:

1. **Driving/Extrication Pad Use: \$15.00 per hour with 72 hours guaranteed per year for a total of 216 hours and a value of \$3,240.00 over the life of this contract.**
2. **Training Tower Use: \$20.00 per hour with 100 hours guaranteed per year for a total of 300 hours and a value of \$6,000.00 over the life of this contract.**

Total Value of Training: \$9240.00 or 516 hours of training.

Additionally, the Township agrees that its training conducted at Butler Tech will be done under the supervision of a certified fire instructor, assistance fire instructor, or officer of the Fairfield Township Fire Department.

Representatives of Butler Tech have inspected the 2010 Chevrolet Horton 4500 Ambulance S#3835 and have determined its suitability for intended use.
