**RESOLUTION AUTHORIZING ADMINISTRATOR TO EXECUTE CONTRACT WITH J.T. LOHRER CONSTRUCTION CO., INC. IN THE AMOUNT OF \$35,700.00 FOR BORING UNDER GILMORE ROAD FOR SEWER EXTENSION TO KETTERING LAND.**

**WHEREAS:** Boring under Gilmore Road has been determined to be the best method for installation of sewer lines across Gilmore Road; and

**WHEREAS:** The Bid of J.T. Lohrer Construction Co., Inc. to perform the work is reasonable; and

**WHEREAS:** The work will reduce future impact to the road and the tie-in will promote economic development.

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

**SECTION 1:** The Board hereby authorizes the Administrator to execute a contract with J.T. Lohrer Construction Co., Inc. to perform boring under Gilmore Road for sewer extension to Kettering land for a total cost of \$35,700.00.

**SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

**SECTION 3** This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

**SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

**SECTION 5:** This resolution shall take effect at the earliest period allowed by law.

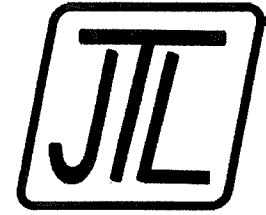
