**RESOLUTION AUTHORIZING THE PURCHASE OF MSA MASK ADAPTERS & FILTERS  
FOR THE FIRE DEPARTMENT FROM VOGELPOHL FIRE EQUIPMENT INC. IN THE  
TOTAL AMOUNT OF \$10,074.78.**

**WHEREAS:** The Fire Chief has recommended the purchase of MSA Mask Adapters & Filters to reduce the risk of contracting COVID-19 and to enhance the safety and welfare of the residents of Fairfield Township; and

**WHEREAS:** The total cost of the MSA Mask Adapters & Filters is \$10,074.78 and will be purchased out of the Coronavirus Relief Fund 2272;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

**SECTION 1:** The Board hereby approves the purchase of MSA Masks from Vogelpohl Fire Equipment Inc. for the Fire Department in the total amount of \$10,074.78, and included herein as Attachment "A".

**SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

**SECTION 3** This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

**SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

**SECTION 5:** This resolution shall take effect at the earliest period allowed by law.




