RESOLUTION AUTHORIZING THE PURCHASE OF LUCAS 3 CHEST COMPRESSION DEVICE, ACCESSORIES AND PROCARE LUCAS PREVENT SERVICE FOR THE FIRE DEPARTMENT FROM STRYKER FOR A TOTAL AMOUNT OF \$19,655.00

WHEREAS: The Fire Chief has recommended the purchase of LUCAS 3 Chest Compression Device, accessories, and ProCare LUCAS Prevent Service to enhance care and treatment of COVID-19 and for the safety and welfare of the residents of Fairfield Township; and

WHEREAS: The total cost of the LUCAS 3 Chest Compression Device and ProCare LUCAS Prevent Service is \$19,655.00 and will be purchased out of the Coronavirus Relief Fund No. 2272;
