**RESOLUTION AUTHORIZING THE PURCHASE OF TURNOUT GEAR FOR THE FIRE
DEPARTMENT FROM PHOENIX SAFETY OUTFITTERS, WARREN FIRE EQUIPMENT &
THE FIRE STORE AT A TOTAL COST OF \$320,442.88.**

WHEREAS: The Fire Chief has recommended the purchase of Turnout Gear to protect Firefighters from contracting COVID-19 and to enhance the safety and welfare of the residents of Fairfield Township; and

WHEREAS: The second set of turnout gear allows for personnel to rotate gear so that it can be cleaned and sanitized, thus adding to employee safety during COVID; and

WHEREAS: The total cost of the Turnout Gear is \$320,442.88 and will be purchased out of the Coronavirus Relief Fund No. 2272;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby approves the purchase of Turnout Gear from Phoenix Safety Outfitters, Warren Fire Equipment & The Fire Store for the Fire Department in the total amount of a \$320,442.88, attached hereto as Exhibit "A".

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.




