**FAIRFIELD TOWNSHIP
RESOLUTION NO. 20-163**

RESOLUTION TO APPROVE PURCHASE OF FOUR (4) 2021 FORD F-150 TRUCKS FROM BEECHMONT FORD, FOR THE FIRE AND ZONING DEPARTMENTS IN THE TOTAL AMOUNT OF \$134,460.00.

WHEREAS: The Administrator has recommended the purchase of new Ford F-150 Trucks to reduce the risk of contracting COVID-19 and to enhance the safety and welfare of the residents of Fairfield Township; and

WHEREAS: The trucks allow for separation of contaminated items from the cab and allow for use in hauling and delivering PPE to various Nursing Homes and Businesses throughout the Township; and

WHEREAS: The total cost of the four (4) New Ford F 150 Trucks is \$134,460.00 and will be purchased out of the Coronavirus Relief Fund No. 2272;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby approves the purchase of four (4) new Ford F-150 Trucks from Beechmont Ford, in the total amount of \$134,460.00, attached hereto as Exhibit "A".

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.


