**FAIRFIELD TOWNSHIP
RESOLUTION NO. 20-165**

**RESOLUTION TO APPROVE PURCHASE OF SIX (6) 2021 FORD SUV INTERCEPTORS
FROM BEECHMONT FORD, FOR THE POLICE DEPARTMENT IN THE
TOTAL AMOUNT OF \$201,042.00.**

WHEREAS: The Police Chief has recommended the purchase of six (6) new SUV Interceptors to reduce the risk of contracting COVID-19 and to enhance the safety and welfare of the residents of Fairfield Township; and

WHEREAS: The additional vehicles will allow a full fleet to stay active while the second fleet is being thoroughly cleaned and disinfected; and

WHEREAS: Patrol officers share vehicles which makes the cleaning necessary for safely maintaining a 24 hour operation; and

WHEREAS: The total cost of the six (6) New SUV Interceptors is \$201,042.00 and will be purchased out of the Coronavirus Relief Fund No. 2272;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby approves the purchase of six (6) new Ford SUV Interceptors from Beechmont Ford, for the Police Department in the total amount of \$201,042.00 attached here as Exhibit "A".

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.


