**RESOLUTION TO APPROVE PURCHASE OF ONE (1) IN-CAR CAMERA SYSTEM
FOR THE F-250 TRUCK FOR THE POLICE DEPARTMENT FROM WATCHGUARD IN THE
TOTAL AMOUNT \$9,345.00.**

WHEREAS: The Police Chief has recommended the purchase of one (1) In-car Camera Systems for the F-250 Truck for the Police Department to enhance the safety and welfare of the residents of Fairfield Township; and

WHEREAS: The total cost of the In-Car Camera System for the F-250 Truck for the Police Department is \$9,345.00 and will be purchased out of the Coronavirus Relief Fund No. 2272;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby approves the purchase of one (1) In-Car Camera System from WatchGuard for the F-250 Truck in the total amount of \$9,345.00 and included herein as Attachment "A".

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.
