RESOLUTION TO APPROVE REPAIR OF FIRE ENGINE #211 FROM SPECIALTY TRUCK REPAIR INC., AT A TOTAL COST OF \$7,500.00.

WHEREAS: Fire Engine #211 needs repairs in order to be fully operational; and

WHEREAS: The repairs will be purchased from Specialty Truck Repair, Inc., out of Fund No. 2111;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

SECTION 1: The Board hereby approves the repair of Fire Engine #211, Specialty Truck Repair, Inc., at a total cost of \$7,500.00, as set forth on attached Exhibit "A".

SECTION 2: The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.

SECTION 3: This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.

SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.
