## RESOLUTION AUTHORIZING THE ADMINISTRATOR TO EXECUTE AGREEMENT WITH THE BUTLER COUNTY EMERGENCY MANAGEMENT COOPERATIVE PROGRAM, AT A TOTAL COST OF \$8,891.61.

**WHEREAS:** The personnel, administrative and operational costs are shared by all political subdivisions that have entered into agreement; and

**WHEREAS:** The Agreement contributes to the health, safety and welfare of the residents of Fairfield Township and will taken out of Fund No.'s 1000, 2031, 2081 and 2111;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- SECTION 1: The Board hereby authorizes the Administrator to execute the Agreement with the Butler County Emergency Management Agency's Cooperative Program, at a total cost of \$8,891.61, due on July 6, 2020, attached hereto as Exhibit "A".
- **SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- **SECTION 4:** That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.
- **SECTION 5:** This resolution shall take effect at the earliest period allowed by law.

The Butler County Emergency Management Agency's personnel, administrative and operational costs are shared by all political subdivisions that have entered into the Butler County Emergency Management Cooperative Agreement. The Fairfield Township share for the 2020 fiscal year will be \$8,891.61.

The per capita amount, .39 represents no increase over the last nine years, as provided in the Butler County Emergency Management Cooperative Agreement. The Fairfield Township population of 22,799 is derived from figures published by the Butler County Engineer's Office 2018 Population Estimates and the 2010 census. The Butler County EMA Executive Committee approved this funding formula at its December 14, 2010 meeting.
