## 2021 Compensation Charts *(updated June 16, 2020)*

Compensation adjustments for township officials were amended into the 132<sup>nd</sup> General Assembly's Senate Bill 296, effective December 27, 2018. The bill provides a 1.75 percent cost of living adjustment (COLA) that began in 2019 and extends through 2028. Only those township officials that are elected or appointed on or after December 27, 2018, are eligible to receive the increase. The Ohio Constitution prohibits elected officials serving a term in office from receiving a raise.

### ***Ohio Constitution, Article II, §20***

*The general assembly, in cases not provided for in the constitution, shall fix the term of office and the compensation of all officers; but no change therein shall affect the salary of any officer during his existing term, unless the office be abolished.*

Per ORC §§505.24 and 507.09, township trustee and fiscal officer salaries are based on the annual budget of the township. If you have any questions about the compensation charts, please do not hesitate to contact the State Association office.
