## FAIRFIELD TOWNSHIP RESOLUTION NO. 21-115

## RESOLUTION AUTHORIZING THE TRANSFER OF TASER CARTRIDGES FROM THE FAIRFIELD TOWNSHIP POLICE DEPARTMENT TO BUTLER TECH.

WHEREAS: Fairfield Township currently owns (25) X26 Taser training cartridges and (31) X26 Taser operational cartridges; and

WHEREAS: The equipment set forth above is obsolete and is no longer needed for public use; and

WHEREAS: Ohio Revised Code §505.10 permits the Board to transfer and convey said items upon whatever terms are agreed to between the Board and another entity; and

WHEREAS: The Fairfield Township Board of Trustees desires to donate the above listed equipment to Butler Tech for training purposes; and

WHEREAS: Butler Tech has agreed to take possession of the equipment to use in the training of their recruits;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- **SECTION 1:** The Board hereby authorizes the transfer of (25) X26 Taser training cartridges and (31) X26 Taser operational cartridges to Butler Tech at no cost.
- **SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

**SECTION 5:** This resolution shall take effect at the earliest period allowed by law.
