FAIRFIELD TOWNSHIP RESOLUTION NO. 21-128

RESOLUTION AUTHORIZING PAYMENT FOR PAVING TO JURGENSEN AT A TOTAL COST OF \$441,191.68.

WHEREAS: The paving list for 2021 was established and money was appropriated for that purpose by the Board on January 27, 2021 via Resolution 21-25; and

WHEREAS: The Fairfield Township Board of Trustees approved a Purchase Order (148-2021) on January 28, 2021, to pay for all services related to the 2021 paving; and

WHEREAS: The Butler County Engineers Office obtained bids for paving on behalf of political subdivisions throughout Butler County; and

WHEREAS: The Butler County Engineers office executed and managed the paving contracts; and

WHEREAS: Butler County selected Jurgensen as the successful bidder to perform the paving contract; and

WHEREAS: It is the responsibility of Fairfield Township to pay Jurgensen for the paving of roads in Fairfield Township;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Trustees of Fairfield Township, Butler County, Ohio, as follows;

- **SECTION 1:** The Board hereby authorizes payment to Jurgensen in the amount of \$441,191.68 for paving work as set forth on the attached Exhibit "A". This will be taken from fund #2021.
- **SECTION 2:** The Board hereby dispenses with the requirement that this resolution be read on two separate days, pursuant to RC 504.10, and authorizes the adoption of this resolution upon its first reading.
- SECTION 3 This resolution is the subject of the general authority granted to the Board of Trustees through the Ohio Revised Code and not the specific authority granted to the Board of Trustees through the status as a Limited Home Rule Township.
- SECTION 4: That it is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in meetings open to the public, in compliance with all legal requirements including §121.22 of the Ohio Revised Code.

SECTION 5: This resolution shall take effect at the earliest period allowed by law.
